Provides social work services to patients at a Community Mental Health & Addiction Services facility. These duties require the performance of social work in helping patients with social, mental, behavioral and related difficulties associated with their mental illness or addiction. The work is performed within prescribed routines, with some leeway permitted in determining the scope of work to be performed in helping the patient more fully integrate into their environment. The Staff Social Worker functions under the direction of a Program Coordinator or Supervising Social Worker who may define or limit the work to be performed. Employees in this class are expected to meet with professionals or agencies in or outside of the community to obtain assistance and guidance for patients. Does related work as required.

MINIMUM QUALIFICATIONS: Either...

- A)** Graduation from a regionally accredited or NYS registered College or University with a Master's Degree in Social Work or Mental Health Counseling and licensure as an LCSW-R or LCSW; **OR**
- B)** Graduation from a regionally accredited or NYS registered College or University with a Master's Degree in Social Work or Mental Health Counseling, licensure as an LMSW, and one (1) year of counseling experience.

NOTE: Unpaid (e.g. volunteer/internship), supervised experience performing the duties of a Staff Social Worker at a local mental health or counseling center in New York State or with the New York State Department of Mental Health will be considered towards the minimum qualifications and *will be evaluated on a case by case basis.*

SPECIAL REQUIREMENT: Must be a Licensed Master Social Worker (LMSW) granted by NYSED; a Licensed Clinical Social Workers (LCSW or LSCW-R) granted by NYSED is preferred.
