In addition to completing our 2022 program, the attached estimate also includes adding four (4) projects totaling 7.92 miles to our 2022 program. The total cost for the additional projects and the asphalt price increase for our 2022 planned program is \$3,549,100. The budget amendment is as follows:

	In July 2021, the bridge carrying County Route 1 over Wolf Creek in the Town of Hadley was yellow flagged due to corrosion and section loss. Saratoga County DPW hired an engineering consultant to prepare design documents for a repair and the project was put out to bid. Town & County Bridge & Rail was the low bid in the amount of \$93,600. Due to escalating costs for construction materials, the low bid exceeded DPW's budgeted amount of \$60,000 for the repair. A budget amendment as follows is requested:			
	Increase Expenses: D.50.511-7502 Contracted Highway Srv \$33,600			
	Increase Revenues: D.50-5031 Transfer from General Fund \$33,600			
	Budget impact statement: Repair costs in excess of \$60,000 will require a transfer from the General Fund.
