#### **County Forestland / Zim Smith Trail Updates/County Grant Updates**

- There are currently 6 pending (down from 8) Open Space/Farmland Protection Projects being administered by the Planning Department, 2 (Town of Northumberland/Bolesh and Town of Galway/Lendl Farm) are submitted for payment. The Town of Halfmoon/Floud has submitted for reimbursement and should close soon, with updated contract. The 2021 Town of Corinth LeClair Project has initiated the reimbursement request process.
- There are currently 16 (down from 19 at last update) pending Trail Projects being administered by the Planning Department, 2 closed since the last update (2019 Town of Galway/Providence, 2019 Town of Wilton, 2019 Project between the Towns of Stillwater, Saratoga, Northumberland, and City of Mechanicville).
- County Fish Stocking efforts were successful and are completed. Attached to the memo are pictures from the school children that participated in some of the fish stocking events.
- The Zim Smith Trail North Design Work was partially funded in the amount \$500,000 in the May TIP update at CDTC.
- Ongoing discussions with NYS Parks and the connection to the County Forestland in Moreau and Moreau Lake State Park.
- The 2022 Open Space Grant Application will be released shortly after the meeting for the 2022 grant cycle. Municipalities are encouraged to contact the Planning Department if they need any assistance with the Application.

#### **Community Forest Update**

Saratoga County, Saratoga PLAN and the Open Space Institute continue to work on the Community Forest Project in Greenfield/Wilton. The project was recently formally named the Graphite Range Community Forest. The Graphite Range Management Board is in the process of preparing the draft Charter and Management Plan for the Community Forest. Once these draft materials are completed they will be sent on to the Committee for their discussion and approval. The trail work (to be completed prior to county purchase) is progressing on schedule for the parcel. The MOA authorized by Resolution 333- 2021 has been executed by all partners and the due diligence is continuing on the purchase. In addition, Saratoga PLAN has approached the County with an addition to the County Forest Project referred to as the Northern Gateway. This additional acquisition will encompass another approximately 20 acres and will coincide with the larger parcel purchase that is covered by the grant from the US Forest Service and Open Space Reserve Funds. There will be no additional cost to the County for this additional acreage. All of the costs associated with this additional acreage will be handled by Saratoga PLAN and reimbursed to the County. A map of the proposed addition is included in this packet. More details on this additional acreage and a Board resolution will be presented at the July Trails and Open Space meeting.








# Town of Wilton, Saratoga County, NY Detail Map of Northern Gateway Tax Parcels








# Town of Greenfield, Saratoga County, NY Detail Map of Northern Gateway and Graphite Range Tax Parcels
