**WHEREAS**, Real Property Tax Law §554 provides the procedure for the correction of errors on the tax rolls, and Real Property Tax Law §556 authorizes the provision for a refund due to a clerical error; and

**WHEREAS**, Real Property Tax Law §550(2)(e) defines a “clerical error” as an entry on a tax roll which is incorrect by reason of a mistake in the determination or transcription of a special assessment or other charge based on units of service provided by a special district; and

**WHEREAS**, eight (8) partial collector units and eight (8) Saratoga lake trunk units were erroneously assigned to tax parcel 229.4-4-11.1, resulting in an overpayment of \$2,692.00 on the 2022 County and Town tax bill; and

**WHEREAS**, our Director of Real Property Tax Services recommends that the error be corrected and a tax refund in the amount of \$2,692.00 be provided to the property owner of record, Malta Land II B, LLC and Malta Land II M, LLC; now, therefore, be it

**CANCELLING DELINQUENT TAXES IN THE TOWN OF HALFMOON**

#### **AUTHORIZING A LEASE AGREEMENT WITH THE SARATOGA COUNTY SOIL AND WATER CONSERVATION DISTRICT**

**WHEREAS**, the Saratoga County Soil and Water Conservation District (“SCSWCD”) is a governmental entity created under the NYS Agriculture and Markets Law whose purpose is to carry out programs for the conservation, use and development of soil, water, and related resources; and

**WHEREAS**, the SCSWCD has its principal office within the County facilities at 50 West High Street (Building 5), and is in need of storage facilities for their equipment; and

**WHEREAS**, the SCSWCD has proposed to lease approximately 9,200 square feet of property owned by the County at the County Farm Road Complex in the Town of Milton whereon the SCSWCD intends to construct a garage to assist with storage of equipment used by the SCSWCD; and

**WHEREAS**, the Commissioner of Public Works has identified a portion of the County Farm Road Complex that is located on an access road to the northwest of the fire training center that would be suitable for the location of the proposed storage garage; and

**WHEREAS**, the SCSWCD has proposed a lease term of thirty (30) years with a mutual renewal option, at a nominal cost of \$1.00 per year, and whereby SCSWCD will be responsible for any and all costs associated with construction and maintenance of the proposed storage garage, and at the conclusion of the lease term ownership of the storage garage would be transferred to the County; and

**WHEREAS**, our Buildings and Grounds Committee and the Commissioner of Public Works have recommended that the County enter into a lease agreement with the Saratoga County Soil and Water Conservation District for the lease of approximately 9,200 square feet of property located at the County Farm Complex in the Town of Milton, for a term of thirty (30) years with a mutual renewal option, at a cost of \$1.00 per year; to include that SCSWCD will be responsible for any and all costs associated with construction and maintenance of the proposed storage garage, and at the conclusion of the lease term ownership of the storage garage would be transferred to the County; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute a lease agreement with the Saratoga County Soil and Water Conservation District for the lease of approximately 9,200 square feet of property located at the County Farm Complex in the Town of Milton, for a term of thirty (30) years with a mutual renewal option, at a cost of \$1.00 per year; to include that the Saratoga County Soil and Water Conservation District will be responsible for any and all costs associated with construction and maintenance of the proposed storage garage, and at the conclusion of the lease term ownership of the storage garage would be transferred to the County; and it is further

**WHEREAS**, the Saratoga County Farmland and Open Space Preservation Program was established in 2003 to give matching grants to purchase development rights or outright ownership of productive agricultural and open space land; and

**WHEREAS**, pursuant to Resolution 282-2021, this Board awarded a 2021 Farmland and Open Space Preservation Grant in the amount of \$32,900 to the Town of Corinth contingent upon Saratoga PLAN completing a fee title acquisition of approximately 132 acres of mature northern hardwood-open space known as the LeClair Preserve property (Tax Parcel 86.-1-25.12) for an estimated price of \$2,500 per acre with the balance of project costs to be paid by a Nature Conservancy Grant and a significant donation from the landowner; and

**WHEREAS**, Resolution 282-2021 estimated the total project costs to be \$387,900; and

**WHEREAS**, in the process of conducting due diligence for the property, Saratoga PLAN has proposed to use the full assessed value of the 152-acre property which will reflect a valuation of \$995 per acre; which will result in a total valuation of the property at \$126,862, thereby reducing the total project cost to \$184,743; and

**WHEREAS**, the reduction in total project costs is greater than the 10% adjustment allowed in Resolution 282-2021 thereby requiring this Board's approval; and

**WHEREAS**, the reduced total project costs are still within the parameters of the Saratoga County Grant Program as the award of \$32,900 remains less than 50% of the total project costs; now, therefore, be it

**WHEREAS**, the County Board of Supervisors of the County of Saratoga, New York on August 17, 2021 adopted a Bond Resolution (the “Prior Bond Resolution”) entitled “RESOLUTION 240-2021. Introduced by Supervisors Schopf, Barrett, Grasso, Tollisen, Veitch, Winney and Wood AUTHORIZING THE ISSUANCE OF \$33,100,000 BONDS OF THE COUNTY OF SARATOGA, OR SO MUCH THEREOF AS MAY BE NECESSARY, TO FINANCE THE COST OF CONSTRUCTION OF UPGRADES TO AMMONIA TREATMENT FACILITIES BY SARATOGA COUNTY SEWER DISTRICT NO. 1; STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$33,100,000, STATING THE PLAN OF FINANCING; PROVIDING FOR A TAX TO PAY THE PRINCIPAL OF AND INTEREST ON SAID BONDS; AND PROVIDING FOR REIMBURSEMENT BY SARATOGA COUNTY SEWER DISTRICT NO. 1 TO SAID COUNTY”; and

**WHEREAS**, the County Board of Supervisors wishes to (i) authorize the expenditure and appropriation of additional funds in connection with the construction of improvements and upgrades to the Saratoga County Sewer District No. 1 (the “District”) facilities in order to treat ammonia, and the acquisition of land or rights in land and acquisition of original furnishings, equipment, machinery or apparatus required in connection therewith (the “Project”); and (ii) authorize the issuance of additional serial bonds of the County to finance such additional appropriation;

**NOW, THEREFORE, BE IT RESOLVED**, by the affirmative vote of not less than two-thirds of the total voting strength of the County Board of Supervisors of the County of Saratoga, New York as follows:

Section 1. The County of Saratoga, New York (herein called “County”), is hereby authorized to undertake the Project at an estimated maximum cost not to exceed \$44,469,202, constituting an increase of \$11,369,202 over the amount previously authorized in the Prior Bond Resolution.

Section 2. The plan for financing such new maximum authorized cost of \$44,469,202 shall be as follows:

(a) By the issuance of \$33,100,000 of Serial Bonds of the County heretofore authorized to be issued pursuant to the Prior Bond Resolution; and

(b) By the issuance of an additional \$11,369,202 of Serial Bonds (the “Bonds”) of the County authorized to be issued pursuant to this Resolution.

Section 3. It is hereby determined that the period of probable usefulness for the specific object or purpose is forty (40) years pursuant to paragraph 4 of Section 11.00(a) of the Local Finance Law; provided, however, that the maximum maturity of the Bonds authorized shall be computed from the date of issuance of (a) the Bonds or the first bond anticipation note issued in anticipation of the Bonds authorized pursuant to this Resolution or (b) the bonds or bond anticipation notes authorized pursuant to the Prior Bond Resolution, whichever date is earlier.

Section 4. Pursuant to Section 107.00(d)(9) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.

Section 5. The temporary use of available funds of the County, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this resolution.

Section 6. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the County, payable as to both principal and interest by a general tax upon all the real property within the County without legal or constitutional limitation as to rate or amount. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be assessed and levied upon the real property of users connected to the District’s sewer system, in accordance with the District’s annual scale of charges for the collection, conveyance, treatment and disposal of sewage and wastewater from public corporations, improvement districts, commercial and industrial users and individuals, as such scale of charges currently exists and as it will be amended and adopted on an annual basis, an amount sufficient to pay the principal of and interest on such obligations as the same become due and payable, but if not paid from such source, all the taxable real property in the County shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal and interest on such obligations when due. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

Section 7. Subject to the provisions of this resolution and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00, inclusive, of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such

notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to issue bonds providing for level or substantially level or declining annual debt service, is hereby delegated to the County Treasurer, the Chief Fiscal Officer of the County.

Section 8. This resolution is intended to constitute the declaration of the County's "official intent" to reimburse the expenditures authorized by this resolution with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by United States Treasury Department Regulation Section 1.150-2. Other than as specified in this resolution, no moneys are reasonably expected to be, received, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

Section 9. The serial bonds and bond anticipation notes authorized to be issued by this resolution are hereby authorized to be consolidated, at the option of the County Treasurer, the Chief Fiscal Officer, with the serial bonds and bond anticipation notes authorized by other bond resolutions previously or heretofore adopted by the Board of Supervisors of the County for purposes of sale in to one or more bond or note issues aggregating an amount not to exceed the amount authorized in such resolutions. All matters regarding the sale of the bonds, including the dated date of the bonds, the use of electronic bidding, the consolidation of the serial bonds and the bond anticipation notes with other issues of the County and the serial maturities of the bonds are hereby delegated to the County Treasurer, the Chief Fiscal Officer of the County.

Section 10. The validity of the Bonds authorized by this resolution and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money; or
- (b) the provisions of law which should be complied with at the date of the publication of this resolution or a summary hereof are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or
- (c) such obligations are authorized in violation of the provisions of the Constitution.

Section 11. The County Treasurer, as Chief Fiscal Officer of the County, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the County to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12, as amended.

Section 12. This resolution, or a summary of this resolution, shall be published in the official newspapers of the County for such purpose, together with a notice of the Clerk of the County in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 13. This resolution is not subject to a mandatory or permissive referendum.

Section 14. The Board of Supervisors of the County hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this resolution.

Section 15. This resolution shall take effect immediately upon its adoption.
