**Introduced by Buildings and Grounds: Supervisors M. Veitch, Connolly, Grasso, Lant, Ostrander, Raymond and Smith**

#### **AUTHORIZING A LEASE AGREEMENT WITH PRIME GROUP HOLDINGS, LLC FOR THE CONSTRUCTION, MAINTENANCE AND USE OF AN AIRPLANE HANGAR AT SARATOGA COUNTY AIRPORT**

**WHEREAS**, Prime Group Holdings, LLC has proposed to lease County owned property at the Saratoga County Airport in the Town of Milton, consisting of .83 acres on the south end of the current Fixed Based Operator (“FBO”) apron for a term of twenty (20) years, beginning September 1, 2022 and continuing through August 31, 2042, subject to mutually agreeable renewal for an additional twenty (20) years, at a monthly cost of \$0.20 per square foot, subject to a five percent (5%) increase every five (5) years; and

**WHEREAS**, Prime Group Holdings, LLC has proposed to use the leased property to construct and maintain a hanger of up to 15,600 square feet (the “Prime Hanger”) for the storage or maintenance of aeronautical equipment including a plane or planes, relocate the airport access road, install a parking field on the Leased Premises, and install signage, at the exclusive cost and maintenance responsibility of Prime Group Holdings, LLC; and

**WHEREAS**, General Municipal Law §325 requires that the proposed lease must be publicly posted and transmitted to the Milton Town Clerk at least ten (10) days in advance of board approval of the proposed lease, and

**WHEREAS**, the Clerk of the Board having publicly posted the proposed lease and notice of public hearing in accordance with applicable law, and the Commissioner of Public Works having transmitted the proposed lease to the Milton Town Clerk on August 4, 2022 in excess of ten days prior to the October 18, 2022 regular Board meeting; and

**WHEREAS**, a Public Hearing was held at the chambers of the Saratoga County Board of Supervisors on August 10, 2022, and the public having had an opportunity to submit comments for this Board’s consideration; and

**WHEREAS**, on September 22, 2022, this Board having referred the proposed lease to the Buildings and Grounds committee for further consideration and review; and

**WHEREAS**, the Buildings and Grounds Committee having recommended approval of the proposed lease with the minor modification of elimination of any terms permitting the lease to be assigned or sublet; and

**WHEREAS**, the proposed construction of a hanger of up to 15,600 square feet, relocation of the airport access road, and installation of a parking field are an Unlisted Action subject to the requirements of the State Environment Quality Review Act (“SEQR”) pursuant to 6 NYCRR Part 617; and

**WHEREAS**, the Saratoga County Board of Supervisors having conducted an uncoordinated review pursuant to 6 NYCRR §617.6; and

**WHEREAS**, the Saratoga County Board of Supervisors having reviewed the potential impacts identified in Parts 1, 2 and 3 of the Short Environmental Assessment Form and as a result has found no significant environmental impacts will occur as the result of the project; now, therefore, be it

**RESOLVED**, that based upon the Project as proposed and the responses set forth in Parts 2 and 3 of the Short Environmental Assessment form prepared for the Project, the Saratoga County Board of Supervisors hereby determines that the Project will not result in any significant adverse environmental impacts to the environment; and it is further

**RESOLVED**, that the Saratoga County Board of Supervisors hereby issues a Negative Declaration for this Unlisted Action pursuant to 6 NYCRR Part 617; and it is further

**RESOLVED**, that the Chair of the Board be, and hereby is, authorized and directed to execute the Environmental Assessment form, a copy of which is attached hereto, indicating the proposed action will not result in any significant adverse environmental impacts; and it is further

**RESOLVED**, that the Clerk of the Board is directed to cause the Negative Declaration to be filed in accordance with the requirements set forth in the applicable administrative and procedural regulations of SEQR; and it is further

**RESOLVED**, that the Chair of the Board is authorized to execute a lease agreement with Prime Group Holdings, LLC, for the exclusive use of County owned property at the Saratoga County Airport in the Town of Milton, consisting of .83 acres on the south end of the current Fixed Based Operator (“FBO”) apron for a term of twenty (20) years, beginning September 1, 2022 and continuing through August 31, 2042, subject to mutually agreeable renewal for an additional twenty (20) years, at a monthly cost of \$0.20 per square foot, subject to a five percent (5%) increase every five (5) years, with such lease permitting Prime Group Holdings, LLC to construct and maintain a hanger of up to 15,600 square feet for the storage or maintenance of aeronautical equipment including a plane or planes, to relocate the airport access road, install a parking field on the Leased Premises, and install signage, and the cost of such construction, improvement and maintenance to be borne exclusively by Prime Group Holdings, LLC; and it is further

**RESOLVED**, that the design and specification of the proposed airplane hangar shall be subject to the approval of the Town of Milton Planning Board; and it is further

**RESOLVED**, that any airplane hangar constructed by Prime Group Holdings, LLC on the leased property shall be subject to property taxes, and to the extent such structure or building is separately assessed, payment of such separately assessed taxes shall be borne exclusively by Prime Group Holdings; and it is further

**RESOLVED**, that the form and content of the lease agreement shall be subject to the approval of the County Attorney; and it is further

**RESOLVED**, that this Resolution shall take effect immediately.

#### **AUTHORIZING THE ACCEPTANCE OF AN UPSTATE AIRPORT REVITALIZATION GRANT FROM THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION**

**WHEREAS**, the County having applied for funding through New York State Department of Transportation's Upstate Airport Economic Development and Revitalization initiative; and

**WHEREAS**, the County having been notified that funding is available in the amount of \$27,000,000 through the New York State's Upstate Airport Economic Development and Revitalization initiative for the design and construction of the "New Fixed Base Operator Terminal Building at Saratoga County Airport"; and

**WHEREAS**, the County desires to advance the Aviation Capital Project, PIN 1902.19, by committing funds for the local match, the funding shares being:

State: \$27,000,000; Local \$3,065,000; Federal \$935,000; and Total \$31,000,000; and

**WHEREAS**, the acceptance of said grant funding requires this Board's approval; now, therefore, be it

**WHEREAS**, CPL has submitted a proposal for additional services related to the ongoing facility assessment study in the amount \$30,000 to complete the final design and construction administration tasks for the Family Court expansion; and

**WHEREAS**, our Buildings and Grounds Committee, the County Administrator, and the Commissioner of Public Works have recommended that the County amend the professional services agreement with Clark Patterson Lee (CPL Architects, Engineers, Landscape Architect and Surveyor, DPC), for a comprehensive facilities assessment study, to provide final design and construction administration services in an amount not to exceed an additional \$30,000, for a total amended agreement cost not to exceed \$191,700; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute an amended professional services agreement with CPL Architects, Engineers, Landscape Architect and Surveyor, DPC, also known as Clark Patterson Lee, of Latham, New York, for the provision of a comprehensive facilities assessment study, and such agreement to include the final design and construction administration services associated with the Family Court expansion project, at an amended total amount not to exceed \$191,700; and it is further

#### **AUTHORIZING AN AGREEMENT WITH QUALTRICS, LLC TO EXPAND ACCESS TO COMMUNITY HEALTH AND HUMAN SERVICE RESOURCES**

**WHEREAS**, pursuant to Resolutions 247-2021, 293-2021, and 54-2022, the County authorized settlement of a litigation related to actions to recover damages in combatting and treating opioid abuse (the “Opioid Litigation”); and

**WHEREAS**, pursuant to the various settlement agreements with Opioid manufacturers and distributors, the County entered into an Opioid Settlement Sharing Agreement which authorizes the damages awarded to the County to be utilized in both restricted and unrestricted manners to mitigate the damage caused by the opioid epidemic; and

**WHEREAS**, the Opioid Settlement Sharing Agreement provides that the restricted use damages award may be utilized to engage services which expand access to care for substance abuse treatment; and

**WHEREAS**, Qualtrics, LLC has provided a proposal to the County Mental Health and Addiction Services Clinic to provide software and CX delivery services related to expanding access to a variety of health and human services resources, including substance abuse treatment and mental health treatment, under a three-year agreement, at a cost of \$14,500 in the first year; \$16,500 in the second year; and \$18,500 in the third year; and

**WHEREAS**, our Health and Human Services Committee and the Director of Mental Health and Addiction Services have recommended that the proposal of Qualtrics, LLC, to provide software and CX delivery services related to expanding access to a variety of health and human services resources, including substance abuse treatment and mental health treatment, under a three-year agreement, at a total cost of \$49,500, be accepted; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute an agreement with Qualtrics, LLC, of Provo, UT, to provide software and CX delivery services related to expanding access to a variety of health and human services resources, including substance abuse treatment and mental health treatment, under a three-year agreement, at a cost of \$14,500 in the first year; \$16,500 in the second year; and \$18,500 in the third year; at a total cost not to exceed \$49,500; and it is further

City of Saratoga Springs: The amount of \$10,000 to be applied towards the Saratoga Springs Blodgett Park Blueway Trail Improvements, including the creation of parallel street parking dedicated to the park, to place fresh stone dust on the trail and to place new signage for the City's access to the Kayaderosseras Creek-Fish Creek Greenway.
2. Town of Clifton Park: The amount of \$10,000 towards the Addison Estates to Settler's Hill Neighborhood Trail Restoration to include the subbase restoration and new asphalt paving of an existing 1+ miles of the 8-ft wide multi-use trail that interconnects the residential neighborhoods.

3. Town of Providence / Town of Edinburg: The combined amount of \$20,000 towards the Fox Hill West Trail Expansion to include the creation of a snowmobile trail connection to the Great Sacandaga Lake by extending the trail eight miles from Fox Hill Rd to the lake through portions of both the Town of Providence and the Town of Edinburg. Construction of the trail will include bridge placement, clearing, grubbing and grading.
4. Town of Greenfield: The amount of \$10,000 towards the Brookhaven Park Trail. Improvement to include the improvement of a 0.5-mile portion of the Brookhaven Trail by placing asphalt surface.
5. Town of Halfmoon: The amount of \$10,000 towards the Champlain Canalway Trail Trailhead - Upper Newtown Road to include creation of a trailhead with parking and crossing delineation and signage on the Northern side of Upper Newtown Road.
6. Town of Malta: The amount of \$8,653 towards the Malta Nature Preserve Trail Restoration to include the restoration of approximately 2,500 linear feet of trail by restoring the trail with crusher run.
7. Town of Moreau: The amount of \$10,000 towards the Scenic Hudson River/Big Bend Trail Phase I Design and Expansion to include the engagement engineering services for site and topographic survey, archaeological services, grant administration services and construction administration services.
8. Town of Saratoga: The amount of \$10,000 towards the Saratoga Boat Launch Improvements Phase II towards the improvements of the boat launch including a kayak/canoe launch, additional picnic tables, BBQ grills, bike rack, picnic shelter and improved parking and access along with added landscaping and signage.

#### **AUTHORIZING THE ACCEPTANCE AND DISBURSEMENT OF NEW YORK STATE SEPTIC SYSTEM REPLACEMENT PROGRAM GRANT FUNDS, AND AMENDING THE 2022 COUNTY BUDGET IN RELATION THERETO**

**WHEREAS**, the New York State Clean Water Infrastructure Act of 2017 established the Septic System Replacement Fund (“the Fund”) to provide property owners a source of funding for the replacement of failing cesspools and septic systems servicing residences and small businesses in New York State; and

**WHEREAS**, the Septic System Replacement Program (“the Program”) is a grant program that seeks to reduce the environmental and public health impacts associated with the discharge of effluent from cesspools and septic systems on groundwater used as drinking water, as well as threatened or impaired waterbodies; and

**WHEREAS**, pursuant to Resolution 79-2018, this board authorized the County to participate in the New York State Environmental Facilities Corporation (“EFC”) Septic System Replacement Program (“the Program”) for the term March 1, 2018 through December 31, 2022, and authorized the execution of a County Participation Agreement with the EFC; and

**WHEREAS**, the Program is being administered for the County by the Saratoga County Soil and Water Conservation District; and

**WHEREAS**, two property owners in the Town of Clifton Park submitted grant applications to the Saratoga County Soil and Water Conservation District requesting an award of Program funds for the replacement of the aging septic system on their properties; and

**WHEREAS**, the Saratoga County Soil and Water Conservation District determined that said proposed septic system projects would significantly and quantifiably reduce potential environmental and/or public health impacts that could result from the aging septic systems, and issued an award letter to the applicants notifying them of the award of Program funds for the reimbursement of their eligible project costs; and

**WHEREAS**, the property owners have completed their septic system replacement projects, and have applied to the Saratoga County Soil and Water Conservation District for the disbursement of their grant award of Program funds; and

**WHEREAS**, the Saratoga County Soil and Water Conservation District made an application to the EFC for disbursement of the Septic System Replacement Program funds awarded for these septic system projects, and EFC has distributed total funds in the amount of \$14,300 to the County in reimbursement of the eligible costs of said projects; and

**WHEREAS**, the acceptance and disbursement of these Septic System Replacement Program grant funds requires this Board’s approval, and an amendment to the 2022 Saratoga County Budget; now, therefore, be it

**RESOLVED**, that the Chair of the Board is hereby authorized to execute all necessary documents and agreements with the New York State Environmental Facilities Corporation for the acceptance of Septic System Replacement Program grant funds in the amount of \$14,300; and it is further

**RESOLVED**, that the form and content of such documents and agreements are subject to the approval of the County Attorney; and it is further

**RESOLVED**, that the 2022 Saratoga County Budget is hereby amended as follows:
