

How do I know what type of driver license or non-driver ID I have?

Standard documents issued after October 30, 2017 have “Not for Federal Purposes” printed in the upper right-hand corner. Any document issued prior to this date is a Standard document.



REAL ID documents have a black circle with a cut-out star in the upper right-hand corner.



Enhanced documents have a gold banner that states “Enhanced” and an American flag in the lower right-hand corner.



How do I get a REAL ID or Enhanced ID?

Please visit one of the Saratoga County DMV offices with the following:

- Proof of identity & legal status
- Proof of citizenship (Enhanced only)
- Proof of social security number (or proof of ineligibility; REAL ID only)
- Two proofs of New York State residency
- Proof of all legal name changes, if applicable

Is REAL ID For Me?

Getting REAL ID is your choice. Depending on your lifestyle, REAL ID may be right for you.



What is REAL ID?

The federal REAL ID Act established minimum security standards for state-issued driver licenses and identification cards and prohibits federal agencies from accepting for official purposes state-issued licenses and identification cards that do not meet these standards.

Beginning May 3, 2023, you will need either a REAL ID compliant card or another form of federally-acceptable identification to board domestic commercial flights, enter a military base, enter a secure federal facility or enter a nuclear facility.

What is Enhanced?

An Enhanced ID is a REAL ID compliant card that is also accepted at U.S. land or sea ports of entry.

Do I have to get a REAL ID?

No. Getting a REAL ID is your choice. Choosing REAL ID depends on your lifestyle and whether you have another form of federally acceptable ID.

How do I determine if REAL ID is right for me?

Choosing REAL ID depends on what you want to use your New York State-issued driver license or non-driver identification card for and whether you have another form of federally-accepted credentials. The following information may help you decide which document is right for you.

New York State-Issued Driver Licenses & Non-Driver ID Cards:

Do you have any of these federally accepted credentials?

- U.S. passport
- U.S. passport card
- DHS trusted traveler card (Global Entry, NEXUS, SENTRI, FAST)
- U.S. Department of Defense ID, including IDs issued to dependents
- Permanent resident card
- Border crossing card
- DHS-designated enhanced driver's license
- Federally recognized, tribal-issued photo ID
- HSPD-12 PIV card
- Foreign government-issued passport
- Canadian provincial driver's license or Indian and Northern Affairs Canada card
- Transportation worker identification credential (TWIC®)
- U.S. Citizenship and Immigration Services Employment Authorization Card (I-766)
- U.S. Merchant Mariner Credential

If you answered, **YES**, you may use that credential to board a commercial aircraft or enter a secure federal facility.

If you answered, **NO**, you will need a REAL ID or Enhanced document to do so.
