

Public Safety Committee Minutes  
November 2, 2022 – 3:00 p.m.

Chairman Lant called the meeting to order and welcomed all in attendance.

**On a motion made by Mr. Hammond, seconded by Mr. Veitch, the minutes of the October 5, 2022 meeting were approved unanimously.**

**A motion was made by Mr. Barrett, seconded by Mr. Hammond, to authorize the acceptance of a New York State Supervision and Treatment Services for Juveniles Program (STSJP) grant, and authorizing provider contracts through December 31, 2023. Unanimous.**  
This grant is in the amount of \$119,550.26.

**A motion was made by Mr. Wright, seconded by Mr. Ostrander, to authorize the acceptance of a County Pretrial Services Grant from the New York State Division of Criminal Justice Services. Unanimous.**  
This grant is in the amount of \$409,280.

**A motion was made by Mr. Barrett, seconded by Mr. Veitch, to authorize the acceptance of an Indigent Legal Services Grant (Distribution #13) from the New York State Office of Indigent Legal Services. Unanimous.**  
This grant is in the amount of \$211,602 over a three year period starting January 1, 2023.

**A motion was made by Mr. Barrett, seconded by Mr. Hammond, to authorize a 2023 contract for police services with the Town of Clifton Park. Unanimous.**  
This agreement is in the amount of \$608,134.57.

**A motion was made by Mr. Hammond, seconded by Mr. Ostrander, to authorize a 2023 contract for police services with the Town of Halfmoon. Unanimous.**  
This agreement is in the amount of \$235,480.66.

**A motion was made by Mr. Barrett, seconded by Mr. Veitch, to authorize the acceptance of aid from the New York State STOP-DWI Foundation, Inc. for DWI High Visibility Engagement Campaign (HVEC) patrols and activities. Unanimous.**

This aid is in the amount of \$28,000.

**On a motion made by Mr. Wright, seconded by Mr. Veitch, the meeting was adjourned unanimously.**
