#### **RESOLUTION 355 - 2022**

CONFIRMING THE DECLARATION OF THE BOARD OF SUPERVISORS TO BE LEAD AGENCY IN THE ENVIRONMENTAL REVIEW OF THE PROPOSED NEW FIXED BASE OPERATOR TERMINAL BUILDING AT THE SARATOGA COUNTY AIRPORT, CLASSIFYING THE PROJECT AS AN UNLISTED ACTION, AND AUTHORIZING THE ISSUANCE OF A NEGATIVE DECLARATION UNDER SEQR

WHEREAS, pursuant to Resolution 298-2022, this Board authorized the acceptance of an Upstate New York Economic Development and Revitalization Grant from the New York State Department of Transportation ("NYSDOT") (PIN 1902.19) for construction of the "New Fixed Base Operator Terminal Building" at the Saratoga County Airport ("the Project"), and appropriated local match funds for the Project; and

**WHEREAS**, pursuant to Resolution 316-2022, this Board authorized an agreement with McFarland Johnson, Inc., of Saratoga Springs, New York, in the amount of \$2,111,081 for professional engineering design and bid services associated with the construction of the "New Fixed Base Operator Terminal Building" at the Saratoga County Airport; and

**WHEREAS**, compliance with the State Environmental Quality Review Act (Article 8 of the Environmental Conservation Law and Part 617 of the New York Code of Rules and Regulations) (SEQR) is required for this project; and

WHEREAS, the Saratoga County Board of Supervisors has declared its intent to act as Lead Agency for the purposes of conducting the environmental review of the proposed construction of the "New Fixed Base Operator Terminal Building" at the Saratoga County Airport, and directed the County Attorney to notify all involved agencies of the Board of Supervisors' intent to act as Lead Agency in accordance with the requirements of 6 NYCRR Part 617.6; and

**WHEREAS**, the County Attorney has notified all involved agencies pursuant to 6 NYCRR Part 617.6 of the Board of Supervisors' intention to act as Lead Agency, and no agencies have objected to the Board's request to act as Lead Agency; and

**WHEREAS**, Parts 1, 2 and 3 of a Short Environmental Assessment Form were completed by McFarland Johnson, Inc., in reference to this project, copies of which are attached hereto; and

**WHEREAS**, the proposed Project is an Unlisted Action pursuant to 6 NYCRR Part 617; now, therefore, be it

**RESOLVED**, that the Saratoga County Board of Supervisors hereby confirms its declaration to act as Lead Agency for the proposed construction of the "New Fixed Base Operator Terminal Building" at the Saratoga County Airport; and it is further

**RESOLVED**, that the proposed construction of the constitutes an Unlisted Action pursuant to 6 NYCRR Part 671; and it is further

**RESOLVED**, that based upon the "New Fixed Base Operator Terminal Building" at the Saratoga County Airport construction project as proposed and the responses set forth in Parts 1, 2 and 3 of the Short Environmental Assessment Forms prepared for the Project, the Saratoga County Board of Supervisors hereby determines that the Project will not have a significant impact on the environment; and it is further

**RESOLVED**, that the Saratoga County Board of Supervisors hereby issues a Negative Declaration for this Unlisted Action pursuant to 6 NYCRR 617.6; and it is further

**RESOLVED**, that the Chair of the Board be, and hereby is, authorized and directed to execute the Environmental Assessment Forms (copies of which are attached hereto) indicating the proposed Project and actions will not result in any significant environmental impact, and it is further

**RESOLVED**, that the Clerk of this Board is directed to cause negative declarations to be filed in accordance with the requirements set forth in the applicable administrative and procedural regulations of SEQR; and it is further

**RESOLVED**, that this Resolution shall take effect immediately.

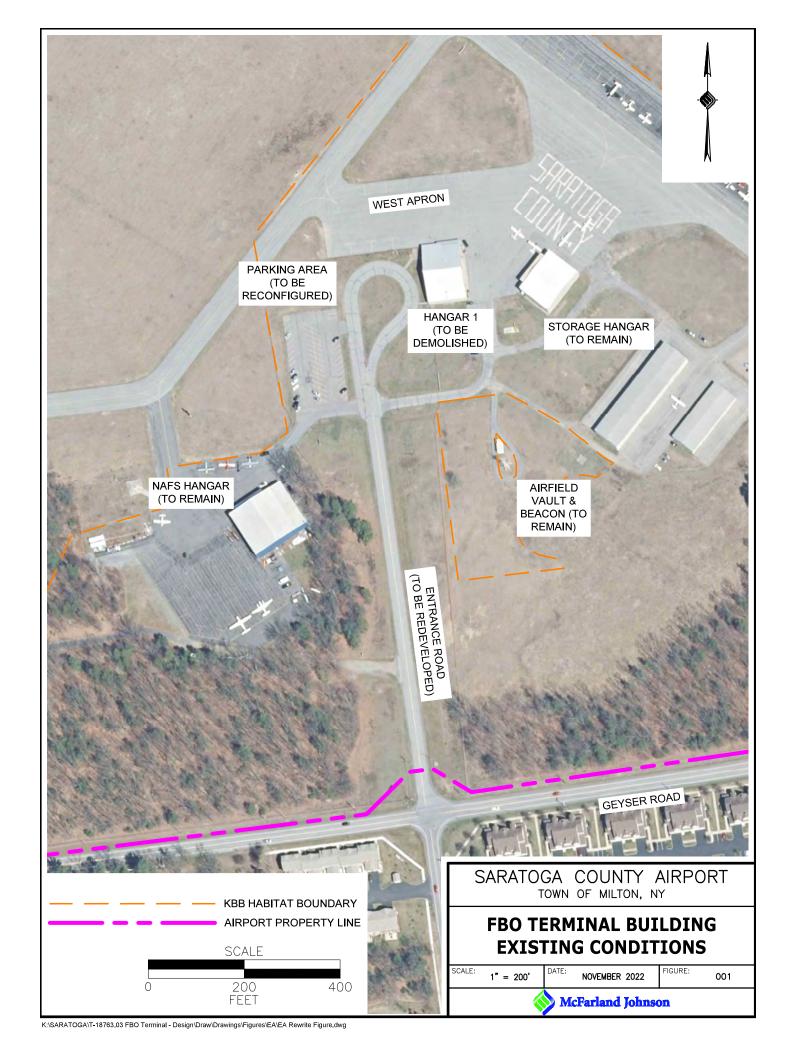

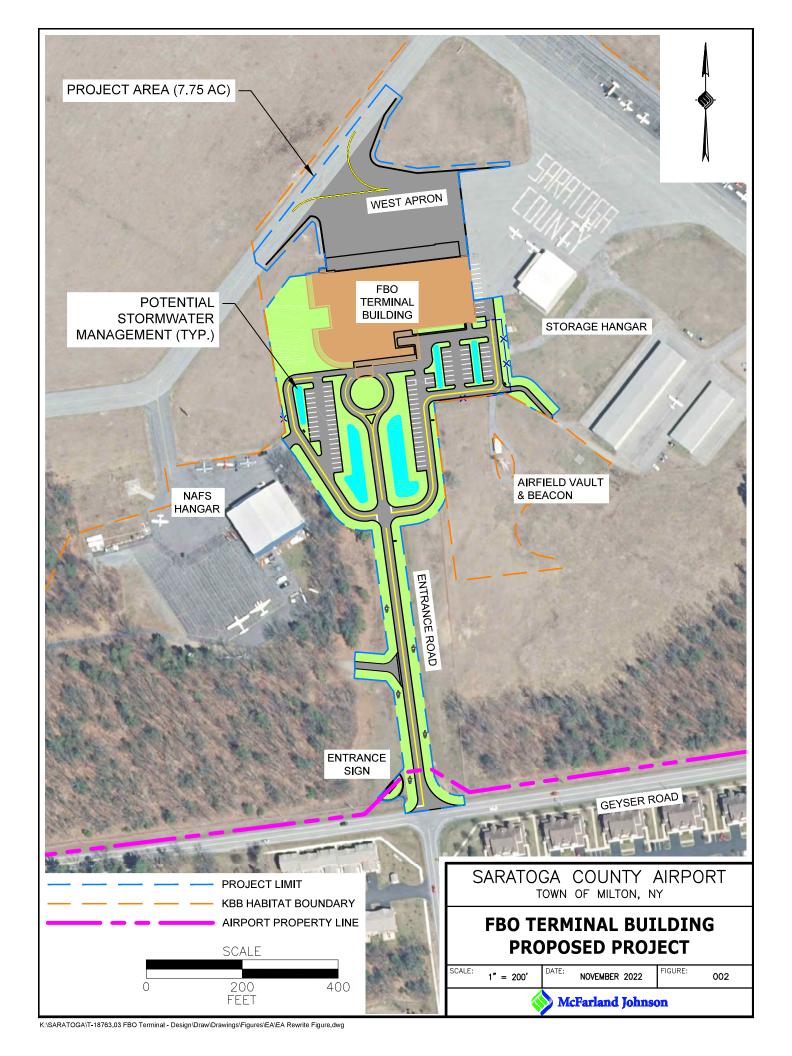

The IPaC indicated the Karner Blue Butterfly and the Monarch Butterfly (Danaus plexippus) as having the potential to exist within the project area. The proposed project area is located within the Karner Blue Butterfly Exempt Zone, per the approved Biological Opinion (BO) dated December 14, 2018. The proposed project area consisting of developed land and upland habitat does not provide adequate habitat (i.e. field, open area, large flat areas of grasses, wet area, or urban garden with many flowers) for these species. Therefore, the proposed project does not have the potential to affect the Karner Blue Butterfly, the Monarch Butterfly or Frosted Elfin. The NYSDEC Environmental Assessment Form (EAF) Mapper and the USFWS Information for Planning and Consultation (IPaC) Official Species List are attached. -A NYSDEC SPDES Stormwater Construction Permit will be obtained to ensure the project is designed with appropriate erosion and sediment controls and post-construction stormwater management features.

McFarland Johnson, Inc. (MJ) has reviewed existing and future traffic conditions associated with the development of a proposed Fixed Base Operator Terminal building and Restaurant at Saratoga County Airport and respectively submits this Letter of Findings. The intent of this letter is to analyze the impacts, if any, that the proposed development may have on the Geyser Road and Greenfield Avenue intersection.

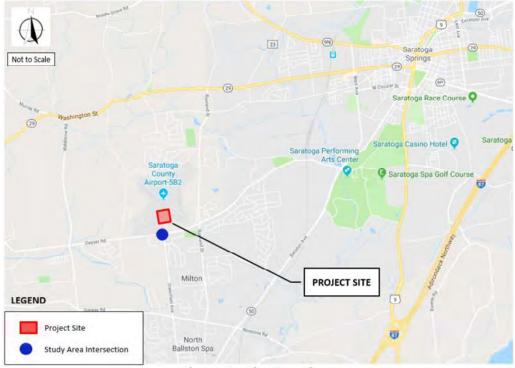


Figure 1 - Site Location

The area to be developed is located within the Airport property on Greenfield Avenue north of Geyser Road as shown in Figure 1 – Site Location. The existing airport entrance intersection is a two-way stop sign controlled intersection with Geyser Road being free flow and Greenfield Avenue having stop signs.

The project consists of construction of a new fixed base operator terminal building with new waiting areas; 75-seat restaurant; concessionaire tenant spaces; rental car lease space; advertisement display lease opportunities; conference room space; weather information access room; pilot lounge area; and connected 39,000 square-foot hangar space. The development includes a rehabilitated access road with approximately 50 parking spaces to replace the existing 50 parking spaces within the area to be removed. Concept Sketch "Proposed Project" figure shows the proposed site plan and is attached to this letter.

### **2022 Existing Traffic Volumes**

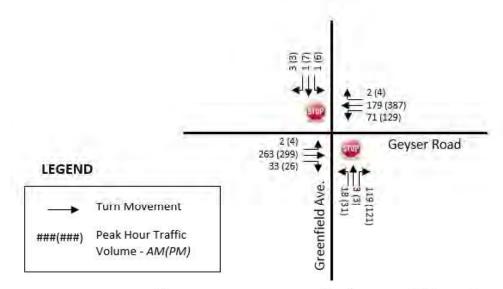


Figure 2 - 2022 Existing Traffic Volumes

Existing traffic volumes were established for this project by recording turn movements counts on Thursday, October 27th, 2022 from 6:45-8:15 AM and 4:15-5:45 PM. The data shows that the weekday traffic in the study area peaks between 7:00 and 8:00 AM in the morning, while the evening traffic peaked between 4:15 and 5:15 PM. The traffic volume data is attached to this letter and the resultant peak hour volume diagram is shown below in Figure 2 – 2022 Base Traffic Volumes. Analysis of the base condition allows the TIS to develop a comparison to future conditions and enables the study to calibrate the traffic model to mimic the present real-life operations that are observed.

### **2024 Background Traffic Volumes**

The 2022 existing traffic volumes were grown by an annual background growth rate of 1.0% per year which enables the analysis to establish projected background volumes to the year 2024 as the terminal is anticipated to be operational by the end of 2024. Based on a review of historic NYSDOT traffic counts on Geyser Road and Greenfield Road, the traffic growth has minor increases and decreases flat over the last 10 years, and a 1.0% annual growth rate was conservatively applied to account for any potential future growth in the area.

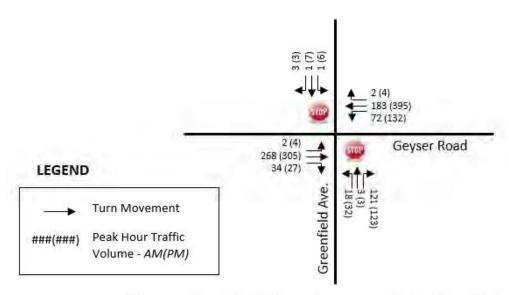


Figure 3 – 2024 Background Traffic Volumes

The 2024 background traffic volumes shown in Figure 3 include existing traffic and the 1.0% annual background traffic growth. These traffic volumes are used as a base in which to add the proposed development's traffic.

### **Trip Distribution**

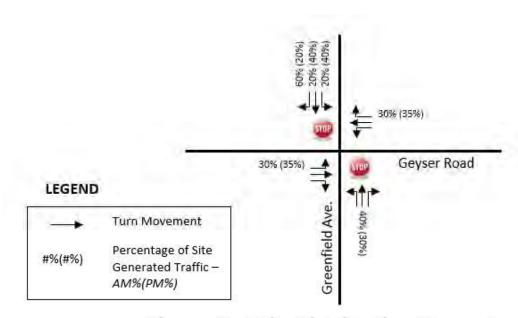


Figure 4 - Trip Distribution Percentages

Development of a projected trip distribution model for this proposed project is based on the existing traffic volumes recorded at the intersection. The trip percentages entering and exiting the proposed development are based on the existing flow of traffic at the intersection since the proposed use is similar if not identical to the current use. See Figure 4 below with the calculated trip distributions for the proposed development's traffic.

#### **Trip Generation**

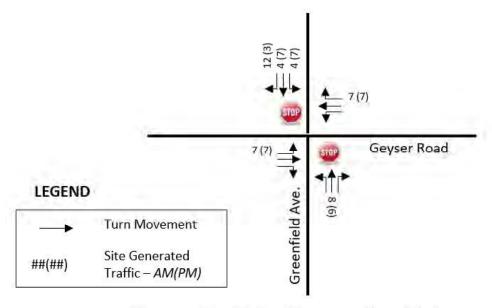


Figure 5 - Trip Generation Volumes

For analysis of the proposed FBO Terminal building development with restaurant, site generated traffic was estimated using trip generation rates provided in the Institute of Transportation Engineers' (ITE) <u>Trip Generation</u> manual, 11th edition as shown in the table below. The analysis utilized the manual's trip generation rates established for a General Aviation Airport (LU#022) and High Turnover (Sit-Down) Restaurant (LU#932). It is conservatively assumed that the proposed project will result in an additional 5 new employees for the airport. The high turnover sit-down restaurant data is more typical of a chain restaurant along a highly traversed roadway; therefore, the estimated trips for the restaurant are also believed to be conservative for the intended restaurant operations within the Terminal building. Based on the nature of the development, no multi-use credit or pass-by trip credit was applied to the 2024 build scenario. See Figure 5 for the projected trips to be generated by the development distributed based on Figure 4.

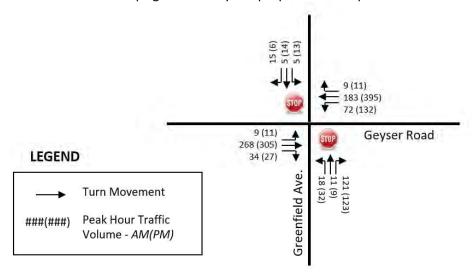


Figure 6 - 2024 Build Traffic Volumes

### **Capacity Analysis**

A capacity analysis was performed using Synchro 8.0 traffic modeling software and the procedures defined in the 2010 Highway Capacity Manual to determine operating conditions for the 2022 Existing, 2024 Background and 2024 Build scenarios. The following Level of Service Summary Table shows the results of the capacity analysis for the proposed conditions, Synchro analysis printouts are attached to this letter.

As shown in the Level of Service Table, the airport entrance intersection would operate at an overall 'A' Level of Service (LOS) for all peak periods. Individual turn movements in the morning peak hour are estimated to have negligible increases in average delay. The northbound and airport driveway exit movements during the evening peak hour are expected to experience 4 and 7 second increases in delay respectively. No mitigation at this intersection is recommended based on the increase in traffic anticipated from the new terminal building.

#### Conclusion

The capacity analysis revealed that the proposed development will have minimal impact to the traffic operations at the intersection of Geyser Road (CR43) and Greenfield Avenue (CR50).

Based on the above noted analysis, the amount of new traffic generated by the proposed FBO Terminal building is believed to be negligible in respect to the existing background traffic currently utilizing the intersection, with only minimal delay increases associated with cars exiting the proposed site.

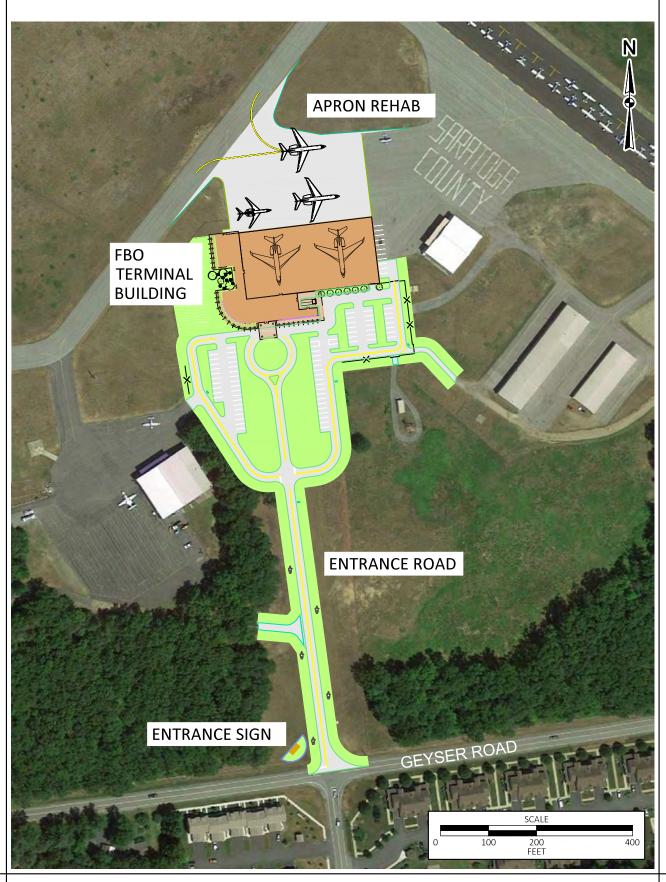

#### Purpose:

To establish a policy and procedure to facilitate, where appropriate, the use of an alternative work arrangement in order to attract and retain a diverse and talented work force, reduce costs, and improve productivity among employees. Saratoga County supports alternative work arrangements and gives authority to department heads to implement a flex schedule arrangement, where appropriate, for eligible employees.

#### **Policy Statement:**

Applicable to all Saratoga County departments where an alternative work arrangement is feasible and appropriate; where an employee's standard workday may be flexed due to employee needs and/or the operational efficiency of a department.

#### Policy and Procedure:

An alternate work arrangement means flexible schedule. This arrangement has been agreed to by the department head and the employee when an employee's schedule is shifted to start or end outside an employee's standard hours of operation. The total number of work hours in the work week and the compensation remain the same.

Alternative Work arrangements may be implemented where appropriate and approved by the department head for eligible employees. Alternative Work arrangements may be made when organizational impacts of such arrangements do not have negative impacts on the department's operation. Negative impact means that the mission of the department is impeded by a flexible work schedule or schedules causing a decrease in services, productivity, production or work quality.

Alternative Work arrangements are not appropriate for all departments. No employee is entitled to, nor guaranteed the opportunity to have an Alternative Work schedule. Offering the opportunity for an Alternative Work arrangement is based on the discretion of the employee's department head. An employee's participation is strictly voluntary. Department heads have the authority to either approve or deny the request. All Alternative Work arrangements must meet the criteria in this policy and may be terminated at any time by the department head or the employee. The department

head and/or the employee shall endeavor to give 5 days' notice when terminating an Alternative Work arrangement. By participating in this voluntary arrangement, employees agree to the terms of this policy and waive their rights to a grievance process.

An employee wishing to request an Alternative Work arrangement shall submit a written request to his/her department head one week from the desired start date. An Alternative Work arrangement must be mutually agreed upon in writing by the employee and department head. Any changes, other than termination of the arrangement, to the written agreement must also be documented in writing and approved by the employee and the department head.

Alternative Work agreements must expire on a routine basis, up to a maximum 3-month period. At the expiration of an Alternative Work agreement, the employee may request renewal of the arrangement one week from the desired end date. The request to renew the arrangement must be made in writing.

The department head will evaluate and adjust Alternative Work arrangements as needed to meet their organizational and workload needs. Adjustments may be made at any time during the agreement, subject to department head approval.

After an employee begins an Alternative Work arrangement, supervisors must conduct periodic reviews with the employee to evaluate the success of the arrangement. The initial Alternative Work agreement shall be reviewed and evaluated during the first 30 days. Subsequent Alternative Work agreements shall be reviewed no less than every 3 months.

Work hours, overtime compensation, and annual leave schedule must conform to state and federal law and the County policies.

Employees must record and report all of their time accurately.

Employees are expected to be working during their Alternative Work schedule without the availability of a direct supervisor and to the extent possible employees must follow all departmental and county policies and procedures during non-standard hours of operation.

The Alternate Work Arrangement Policy is not a substitute for requests for accommodation due to disability, a serious medical condition, or for some other statutorily proscribed reason. Those requests must be made separately in accordance with County policy and procedure.

#### Alternative Work Arrangement Eligibility:

Characteristics of the employee will include a demonstrated conscientiousness about work time and productivity, self-motivation and the ability to work well alone. The employee communicates effectively with supervisors, co-workers, support staff and public.

To the Town of Charlton, the sum of \$220,000; upon the condition of Saratoga PLAN completing a bargain sale, plus in-kind donations, for an estimated price of \$3,400 per acre for the purchase of development rights of a 154.4-acre parcel (SBL No.: partial-223.-1-13.12, 223.-1-13.2 and partial-223.-1-12). The disbursement is further conditioned upon a county snowmobile trail connector being allowed on the parcel and the successful State funding of landowner's adjoining parcel for preservation. The total project cost is estimated at \$524,425.

#### 2. Town of Milton:

To the Town of Milton, the sum of \$124,762; upon the condition of Saratoga PLAN completing a bargain sale, plus in-kind donation, towards an estimated price of \$5,900 per acre for the purchase of development rights of a 42-acre farming operation (SBL #: 214.-1-23.1). The total project cost is estimated at \$249,524.

**WHEREAS**, a County may establish a Tax Stabilization Reserve Fund for "unanticipated expenditures," "unanticipated revenue loss," or "public emergencies" as those terms are defined by General Municipal Law §6-e; and

**WHEREAS**, the monies in such fund must be deposited and secured in a manner as provided by General Municipal Law §10; and

**WHEREAS**, pursuant to Resolution 247-2022, this Board authorized the creation of a Tax Stabilization Reserve Fund for purposes enumerated in General Municipal Law §6-e; and

**WHEREAS**, pursuant to General Municipal Law §6-e(4), the establishment of a Tax Stabilization Fund is subject to a permissive referendum wherein publication of the authorizing resolution is required within certain time frames; and

**WHEREAS**, due to a clerical oversight, publication of Resolution 247-2022 was not completed within the time frames required for resolutions subject to a permissive referendum as established and required by County Law §§ 101 - 103, *et seq.*; and

WHEREAS, the Board still intends to create and otherwise establish a Tax Stabilization Reserve Fund, and as a result of the deficiencies in publication of Resolution 247-2022, the County Attorney has recommended that the Board rescind Resolution 247-2022, and has recommended that the Board issue a new authorizing resolution creating and otherwise establishing a Tax Stabilization Reserve Fund, the creation thereof being subject to the requirements of General Municipal Law §6-e; and

**WHEREAS**, our Law and Finance Committee, the County Treasurer, the Director of Finance, and the County Administrator have recommended that a Tax Stabilization Reserve Fund be created for "unanticipated expenditures," "unanticipated revenue loss," or "public emergencies" as those terms are defined by General Municipal Law §6-e, and that upon the proper establishment of the Tax Stabilization Reserve Fund, that \$2,000,000 of unassigned fund balance be appropriated to the fund; now, therefore, be it

**RESOLVED**, that Resolution 247-2022 is hereby rescinded in its' entirety; and it is further

**RESOLVED**, that the Saratoga County Board of Supervisors hereby establishes an account to be known as the "Tax Stabilization Reserve Fund" to be used for purposes as enumerated in General Municipal Law §6-e; and it is further

**RESOLVED**, that such monies in such fund shall be deposited and secured in a manner as provided in General Municipal Law §10, and the County Treasurer shall invest the monies in such fund in the manner provided by General Municipal Law §11, and any interest earned or capital gains realized on the monies so deposited or invested shall continue to accrue and become part of such fund; and it is further

**RESOLVED**, that except as otherwise provided for by law, expenditures from the Tax Stabilization Reserve Fund shall be made only for approved purposes as provided for by General Municipal Law §6-e. No expenditure may be made from the Tax Stabilization Reserve Fund without the approval of the Board of Supervisors, and such actions and proceedings as may be required by General Municipal Law §6-c, or any other law, including a permissive referendum as required by General Municipal Law §6-c(4); and it is further

**RESOLVED**, that this Resolution is subject to a permissive referendum as provided for by County Law §§ 101 - 103, *et seq.*, and the Clerk of the Board be and is hereby directed to publish notice of this Resolution in accordance with County Law §101(a); and it is further

**RESOLVED**, that upon the creation of the Tax Stabilization Reserve Fund, this Board appropriates and directs that \$2,000,000 from the unassigned fund balance be transferred to the Tax Stabilization Reserve Fund; and it is further

**RESOLVED**, that upon the creation of the Tax Stabilization Reserve Fund, the Director of Finance and/or the Budget Officer is authorized to effectuate the following transfer of funds:

**Increase Special Reserves** 

Acct.: # A-0888.TS - Special Reserves – Tax Stabilization \$2,000,000
