This is skilled work involving responsibility for the overhaul, repair and maintenance of a wide variety of automotive and/or equipment including but not limited to engines, motors, motor-powered equipment, heavy construction, truck and automotive machinery. The work requires a thorough knowledge of the heavy truck/construction equipment repair trade or automotive repair trade. Ability to conduct NYS inspections of light and/or heavy fleet vehicles is a regular requirement of this position. Complete set of mechanics tools/ storage will be necessary (partial stipend provided). General instructions are received from a higher-ranking Supervisor regarding tasks to be performed, with considerable leeway permitted in planning the details of each assignment. Supervision may be exercised over the work of other lower-level department technicians and/or operators; Does related work as required. (This is a 40 Hour, Mon-Fri vacancy with voluntary over-time opportunities available)

**MINIMUM QUALIFICATIONS:** Graduation from High School or possession of an equivalency certificate (GED) and at least, four (4) years of experience as an automotive or diesel mechanic which must have included diagnosis, repair and maintenance of automotive or diesel systems.
