#### County Forestland / Zim Smith Trail Updates / County Grant Updates

- There are currently 8 pending Open Space/Farmland Protection Projects being administered by the Planning Department. Of the 8 projects, 4 are 2022 (last year) awards and 4 are prior awards. Town of Clifton Park 2019 Open Space project is ready for reimbursement as we wait for the amended contract to be fully executed.
- There are currently 16 pending Trail Projects being administered by the Planning Department. Of the 16 projects, 12 are 2022 (last year) awards and four are prior awards. A 2019 trail grant award for the Town of Milton was closed in December 2022, 2019 and 2020 trail grant awards to the Town of Edinburg, and 2021 Town of Clifton Park trail grant closed in January. The Town of Edinburg will be providing additional information for their 2021 trail grant award and that will be closed out.
- Additional wetland delineation work has been completed on the Zim Smith North Project and survey work is mostly complete. A concerned landowner has reached out and additional routes are being evaluated.
