#### **AUTHORIZING USE OF OPIOID SETTLEMENT FUNDS BY SARATOGA COUNTY DEPARTMENT OF HEALTH TO SUPPORT PREVENTION PROGRAMS, PREVENT MISUSE OF OPIOIDS, AND PREVENT OVERDOSE DEATHS AND OTHER HARMS, AND AMENDING THE 2023 COUNTY BUDGET IN RELATION THERETO**

**WHEREAS**, pursuant to Resolution 203-2017, this Board authorized the commencement of litigation against the manufacturers, distributors, and certain prescribing physicians of opioid pharmaceuticals to recover damages resulting from the County combatting and treating opioid abuse, and further authorized the retention of Napoli Shkolnik, PLLC to serve as special counsel with respect to the initiation and prosecution of such litigation; and

**WHEREAS**, the County of Saratoga and many other municipalities are a member of a lawsuit commenced in Suffolk County against manufacturers, distributors, and certain prescribing physicians of opioid pharmaceuticals; and

**WHEREAS**, due to settlement of certain lawsuits, the County of Saratoga received funds to be utilized for opioid remediation to address the misuse and abuse of opioid products, to treat or mitigate opioid use or related disorders, or mitigate other alleged effects of the opioid epidemic, including, but not limited to utilization of naloxone or other FDA-approved drugs to reverse opioid overdoses, drug disposal systems, fentanyl and xylazine test strips; evidence-based data collection, and research analyzing the effectiveness of the abatement strategies within the state; and

**WHEREAS**, the Saratoga County Department of Health (DOH), will increase availability and distribution of naloxone with naloxbox program, and purchase additional ancillary supplies, **such as drug disposal systems and drug test strips**, to be included in the County's Overdose Rescue kits, which will be distributed at community events, and will be displayed on the County Dashboard shared with the community-based organizations; and

**WHEREAS**, our Health and Human Services Committee, and the Commissioner of Health have recommended the authorization of opioid funds to support the DOH's initiatives to combat substance use disorder including the necessary budget amendments; now, therefore, be it

**RESOLVED**, that opioid settlement funds received by the County of Saratoga in the amount of \$72,000 are authorized to be used to support the DOH's initiatives to combat substance

use disorder, including but limited to: increase the availability and distribution of naloxone with naloxbox program, and purchase additional ancillary supplies, **such as drug disposal systems and drug test strips**, to be included in the County’s Overdose Rescue kits, which will be distributed at community events, and will be displayed on the County Dashboard shared with the community-based organizations, and including the necessary budget amendments; and it is further

**WHEREAS**, the County of Saratoga and many other municipalities are a member of a lawsuit commenced in Suffolk County against manufacturers, distributors, and certain prescribing physicians of opioid pharmaceuticals; and

**WHEREAS**, due to settlement of certain lawsuits, the County of Saratoga received funds to be utilized for opioid remediation to address the misuse and abuse of opioid products, to treat or mitigate opioid use or related disorders, or mitigate other alleged effects of the opioid epidemic, including, but not limited to corrective advertising or affirmative public education campaigns based on evidence, funding evidence-based prevention programs in schools, and school-based programs that have demonstrated effectiveness in preventing drug misuse; and

**WHEREAS**, the Saratoga County Department of Health (DOH), has identified school-based programs presented by Herren Talks, Inc. and Speak Sobriety LLC to be presented to students in several schools throughout Saratoga County to support school-based programs to prevent drug misuse; and

**WHEREAS**, our Health and Human Services Committee, and the Commissioner of Health have recommended the authorization of opioid funds to support the DOH's initiative to provide school-based programs to prevent drug misuse now, therefore, be it

**RESOLVED**, that opioid settlement funds received by the County of Saratoga in an amount not to exceed \$44,000 are authorized to be used to support the DOH's initiatives to provide school-based programs to prevent drug misuse, including related travel expenses associated with the

presentations, by Herren Talks, Inc. and Speak Sobriety LLC, and the necessary budget amendments; and it is further

**RESOLVED**, that the Chair of the Board is authorized to execute an agreement with Herren Talks, Inc. of Portsmouth, Rhode Island to provide school-based programs to prevent drug misuse, including related travel expenses associated with the presentations, in an amount not to exceed \$30,000; and, it is further

**RESOLVED**, that the form and content of such agreement shall be subject to the approval of the County Attorney; and it is further

### **AUTHORIZING AN AGREEMENT WITH NIXON PEABODY, LLP FOR THE PROVISION OF PROFESSIONAL LEGAL SERVICES**

**WHEREAS**, Saratoga County Department of Health is transitioning to a Full-Service Health Department, and such transition requires extensive and specialized legal representation including regulatory, grant administration, compliance and licensing components; and

**WHEREAS**, the County previously entered into a contract with Nixon Peabody, LLP for professional legal services related to the Department of Health's transition to a full-service health department; and

**WHEREAS**, Nixon Peabody, LLP has demonstrated exceptional quality of legal services rendered; and

**WHEREAS**, Nixon Peabody, LLP has submitted a Letter of Engagement dated May 25, 2023, to provide legal services required for the enforcement of the New York State Sanitary Code, and other legal counsel related to assisting the Department of Health with its transition to a Full-Service Local Health Department, as needed and requested, for the term June 1, 2023 through June 1, 2025, at the rate of \$300 per hour for new associates up to \$650 per hour for services provided by senior partners, and \$200 to \$275 per hour for services provided by legal assistants; plus any additional charges including but not limited to: duplicating, messenger and delivery, travel, and filing fees, with an allocation for overhead to those charges as appropriate; and

**WHEREAS**, the Health and Human Services Committee and the Commissioner of the Department of Health have recommended that the County enter into an agreement with Nixon Peabody, LLP for professional legal services; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute an agreement with Nixon Peabody, LLP of Albany, New York, for professional legal services related to general and specialized legal matters, including, but not limited to providing legal services required for the enforcement of the New York State Sanitary Code, and other legal counsel related to assisting the Department of Health with its transition to a Full-Service Local Health Department, for the term of two (2) years commencing June 1, 2023 and continuing through June 1, 2025 at the rate of \$300 per hour for new associates up to \$650 per hour for services provided by senior partners, and \$200 to \$275 per hour for services provided by legal assistants; plus any additional charges including but not limited to: duplicating, messenger and delivery, travel, and filing fees, with an allocation for overhead to those charges as appropriate; and be it further

**RESOLVED**, that the form and content of such an agreement shall be subject to the approval of the County Attorney.

#### **AUTHORIZING AN INTERMUNICIPAL AGREEMENT WITH THE TOWN OF WILTON AND AMENDING THE 2023 BUDGET IN RELATION THERETO**

**WHEREAS**, pursuant to Resolution 192-2022, this board authorized funds received under the American Rescue Plan Act of 2021 to be used for the Rehabilitation of County Road 33 (CR 33) in the town of Wilton; and

**WHEREAS**, pursuant to Resolution 235-2022, the board authorized an agreement with Greenman-Pedersen, Inc., of Babylon, New York, for design and construction inspection services associated with the rehabilitation of CR 33 in the Town of Wilton; and

**WHEREAS**, the Town of Wilton is requesting improvements on Town owned infrastructure that abut CR 33/Ballard Road; and

**WHEREAS**, the estimated budget for the project which did not include the Town of Wilton improvements was \$1,476,597, and the lowest bidder for the project is \$2,263,529; and

**WHEREAS**, it is appropriate that the County of Saratoga enter into an intermunicipal agreement with the Town of Wilton, and the Town's portion of the total project cost is \$587,651, which includes an additional fee of \$16,000 for Greenman-Pedersen, Inc for construction administration and inspection services for the Town of Wilton's infrastructure; and

**WHEREAS**, the remaining cost that exceeds the original budget will be funded through additional CHIPS funding the County has received totaling \$215,282; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute an Intermunicipal Agreement with the Town of Wilton to effectuate the necessary highway improvements within the CR 33 corridor, with the Town of Wilton responsible for \$587,651, and the remaining cost that exceeds the original budget will be funded through additional CHIPS funding the County has received totaling \$215,282; and it is further

**RESOLVED**, that the Chair of the Board is authorized to execute an amended agreement with Greenman-Pederson, Inc. of Babylon, New York, for an additional amount of \$16,000 for construction administration and inspection services for the Town of Wilton's infrastructure; and it is further

### **AUTHORIZING AN INTERMUNICIPAL AGREEMENT WITH THE TOWN OF MOREAU FOR JOINT FINANCING, CONSTRUCTION, OPERATION AND GOVERNANCE OF A COUNTY FORCE MAIN CONNECTION**

**WHEREAS**, by proceedings heretofore duly had and taken pursuant to Article 5-A of the County Law, the Board of Supervisors of Saratoga County, New York, has established a county sewer district designated and known as Saratoga County Sewer District No. 1, in said County (the "District"); and

**WHEREAS**, the Town of Moreau created the Moreau Sewer District 1, Extension 5 to promote economic development and groundwater resource protection; and

**WHEREAS**, Saratoga County determined it will be mutually beneficial and in the best interest of the general public to connect Moreau Sewer District 1, Extension 5 to the County collection treatment system, hereinafter referred to as the "County Force Main Connection"; and

**WHEREAS**, both the Town of Moreau and the County of Saratoga recognized that an agreement was needed to set forth the duties and responsibilities of each municipality for the County Force Main Connection; and

**WHEREAS**, Resolution 130-2022 authorized the Chair of the Board, or Vice-Chair in his absence, to execute an intermunicipal agreement ("Intermunicipal Agreement") with the Town of Moreau to connect the Town's sanitary sewer system to the County's collection treatment system; and

**WHEREAS**, the Town of Moreau and County of Saratoga executed an intermunicipal agreement on April 6, 2022 setting forth the rights, duties, obligations, and responsibilities for each regarding the construction of the County Force Main Connection, and that it is the intent of both parties that this agreement shall remain in effect until construction is complete; and

**WHEREAS**, a new intermunicipal agreement ("Intermunicipal Agreement") is necessary between the Town of Moreau and the County of Saratoga to set forth the dedication of the County Force Main Connection to the District, institute billing practices per the Scale of Charges, and establish current or future obligations both entities have to construct, maintain and operate the County Force Main Connection; and



**WHEREAS**, this Board has agreed to commit American Rescue Plan Act grant funds to the project sufficient to evaluate, design, permit, and allow partial construction of the County Connection; and

**WHEREAS**, Resolution 100-2022 authorized a commitment of \$2,000,000 in American Rescue Plan Act funding for the extension of sewer infrastructure to the Towns of Moreau and Wilton; and

**WHEREAS**, additional funding sources are needed to help offset the cost of the County Force Main Connection project; and

**WHEREAS**, this Intermunicipal Agreement is required for the County of Saratoga to apply for grant funding under the New York State Water Infrastructure Improvement Act (“WIIA”) program; and

**WHEREAS**, the Chair of the Board, or the Vice-Chair in his absence, or the Executive Director of the Saratoga County Sewer District No. 1 have been granted authority to process the submission of the intermunicipal grant (“IMG”) application under WIIA on behalf of the County; and

**WHEREAS**; the District has confirmed sufficient system capacity exists based on flow assumptions provided; and

**WHEREAS**, it would appear that the construction of the County Force Main Connection would be in the best interests of the people of the County of Saratoga residing within the boundaries of the District; and

**WHEREAS**, our Law and Finance Committee and the Executive Director of Saratoga County Sewer District No. 1 have recommended that the County enter into an Intermunicipal Agreement with the Town of Moreau to implement the County Force Main Connection with Moreau Sewer District 1, Extension 5; now, therefore, be it

**RESOLVED**, that the Chair of the Board, or the Vice-Chair of the Board in the Chair’s absence, are authorized to execute an Intermunicipal Agreement pursuant to General Municipal Law §119-o and Local Finance Law §11 between the Town of Moreau, on behalf of the Town of Moreau Sewer District 1, Extension 5, and the County of Saratoga, on behalf of Saratoga County Sewer District No. 1, providing for the joint construction, financing, operation and governance of the County Force Main Connection; and be it further

**RESOLVED**, that the form and content of such an Intermunicipal Agreement shall be subject to the approval of the County Attorney; and be it further

**RESOLVED**, the Chair of the Board, or the Vice-Chair in his absence, or the Executive Director of the Saratoga County Sewer District No. 1 are authorized to submit the IMG grant application on behalf of the County for grant funding under the New York State Water Infrastructure Improvement Act Program, and the County Treasurer is authorized to execute any

agreements, instruments or other documents in connection with the County's acceptance of any such grants and/or the funding thereof; and, be it further

**RESOLVED**, that the Board acknowledges that any grant award funding through the New York State Water Infrastructure Improvement Act Program may be subject to a required local match with respect to financing or grants awarded to the County for the Project through the use of cash and/or in-kind services; and be it further

**RESOLVED**, that this Resolution shall take effect immediately.

#### **AUTHORIZING A REVENUE SHARING AGREEMENT WITH THE TOWNS AND CITIES RELATIVE TO HOST COMMUNITY BENEFIT PROGRAMS RECEIVED FROM THE CHPE, LLC IN CONNECTION WITH THE CHAMPLAIN HUDSON POWER EXPRESS PROJECT**

**WHEREAS**, CHPE, LLC, a New York State limited liability company (the “Company”), has undertaken a project (the “Project”) consisting of the construction, installation and equipping on or under the Land of a fully-buried, up to 1,250-megawatt (“MW”) high voltage direct current (“HVDC”) electric transmission line and related infrastructure (collectively, the “Improvements”) that will travel through the Towns of Moreau, Northumberland, Wilton, Greenfield, Milton, Ballston, Clifton Park, and the City of Saratoga Springs, and the acquisition and installation thereon and therein of certain related machinery and equipment, including but not limited to, two (2) five-inch diameter HVDC transmission cables (collectively, the “Equipment”) (the Land, the Improvements and the Equipment hereinafter collectively referred to as the “Project Facility”), all of the foregoing to be used and operated by the Company as a portion of an electric power transmission line from the U.S.-Canada border to New York City; and

**WHEREAS**, pursuant to Resolution 268-2022, this Board authorized a “Host Community Benefit Agreement” (Agreement) in connection with the undertaking of the Project, by and between the County of Saratoga (County) and the Company, to which the Company, as part of the Agreement, will make payments, commencing in 2026 or 2027, totaling \$126,888,420 to the County over a thirty-year (30) period to offset impacts within the County for the overland route; and

**WHEREAS**, our Law and Finance Committee and the Saratoga County Industrial Development Agency have recommended the \$126,888,420 be distributed as listed in Schedule A: 1/3 divided equally between all 21 towns/cities; 1/3 divided equally between the eight (8) towns impacted by the line running through their municipality, and 1/3 to the County to be dedicated to the Capital Facilities Reserve Fund; now, therefore, be it

**RESOLVED**, that the Saratoga County Board of Supervisors hereby approves the Revenue Sharing Agreement with the towns and cities relative to Host Community Benefit payments received from CHPE, LLC in connection with the Champlain Hudson Power Express Project, totaling \$126,888,420 be distributed as listed in Schedule A: 1/3 divided equally

between all 21 towns/cities; 1/3 divided equally between the eight (8) towns impacted by the line running through their municipality, and 1/3 to the County to be dedicated to the Capital Facilities Reserve Fund be , and it is further

**RESOLVED**, that this resolution shall take effect immediately.

### **RESOLUTION 175 - 2023**

**Introduced by Law and Finance: Supervisors Schopf, Barrett, Edwards, Lant, Tollisen and M. Veitch**

### **URGING THE GOVERNOR TO VETO A.04282B/S.3505B TO MOVE CERTAIN LOCAL ELECTIONS TO EVEN- NUMBERED YEARS**

**WHEREAS**, the Saratoga County Board of Supervisors believes that increasing participation in the election process and reducing cost of government options is good for our republic; and

**WHEREAS**, Assembly Member Amy Paulin and State Senator James Skoufis reintroduced legislation that would move local elections to even-number years during the 2023 legislative session; and

**WHEREAS**, versions of this legislation were introduced in previous years and failed to reached the floor for a vote due to a lack of support; and

**WHEREAS**, after the 2022 sessions concluded, the bill sponsor indicated that hearings would be held on the proposal through the Election Committee process; however, there were no hearings held; and

**WHEREAS**, the legislation passed in the middle of the night on the last days of the legislative session which is counter to the idea of an open and transparent government; and

**WHEREAS**, the Saratoga County Board of Supervisors has several concerns with this bill; and

**WHEREAS**, this legislation usurps the home rule powers reserved by local governments and protected by the Constitution of the State of New York, raising questions of legality and constitutional authority; and

**WHEREAS**, local municipalities have had the ability to change their elections to even-number years for decades, and chose not to do so; and

**WHEREAS**, we believe that establishing the schedule of local elections is that right of the local government, and has been for more than 100 years; and

**WHEREAS**, the Assembly Bill sponsor indicated that she had not received any messages of support for this proposal from any of the 57 Counties and 933 towns across New York State impacted by this legislation; and

**WHEREAS**, this legislation excludes more than half of all New Yorkers who vote in cities and villages from changes to election law, creating an inequity among New York voters; and

**WHEREAS**, this legislation unfairly excludes the elections to offices in New York City and all other cities and villages in New York State, as well as certain offices within all counties and towns; and

**WHEREAS**, the proposed legislation circumvented the legislative committee process during this session, limiting public input and understanding of the impact; and

**WHEREAS**, there has been no financial analysis or operational analysis of the impact on local Board of Elections; and

**WHEREAS**, there are concerns that the election and ballot counting technology would not be able to adequately meet the demands of the significantly increased ballot size; and

**WHEREAS**, this will create confusion amongst voters in towns and counties across New York State; and

**WHEREAS**, separating the elections affords voters more time to better understand important local issues and provides candidates the appropriate platform to explain their stance on issues; and

**WHEREAS**, moving local elections to even-numbered years would increase the cost of campaigns for local office, reducing the number of candidates willing to invest funds into their own campaign, because the cost of media will increase to compete with national and state level campaign advertisements; and

**WHEREAS**, there are significant legal and constitutional questions regarding the legality of this measure that have not been adequately addressed; now, therefore, be it

**RESOLVED**, that this Board of Supervisors urges the Governor to oppose this legislation and utilize her veto authority to reject this proposal; and be it further

**RESOLVED**, that copies of this resolution be distributed by the Clerk of the Board of Supervisors to Governor Kathy Hochul, Senate Majority Leader Andrea Stewart Cousins, Assembly Speaker Carl Heastie, Senate Minority Leader Robert Ort, Assembly Minority Leader William Barclay, Assembly Bill Sponsor Amy Paulin, Senate Bill Sponsor James Skoufis, Senator James Tedisco, Assemblymember John McDonald, Assemblymember Mary Beth Walsh, Assemblymember Carrie Woerner, and Assemblymember Matthew Simpson.
