WHEREAS, certain former owners have requested the pre-auction conveyance of one or more of said parcels in consideration of the payment of an amount equal to the unpaid taxes, penalties, interest and charges, ("Tender Offers"); and

WHEREAS, our Real Property Tax Committee recommends the Board of Supervisors grants its approval of these Tender Offers thereby removing those parcels from the County's upcoming Real Property Tax Auction; now, therefore be it

RESOLVED, that the Real Property Tax Committee authorizes the inclusion of Tender Offers received after its March 7, 2023 meeting on a resolution for consideration by the Board of Supervisors, and recommends the approval of such offers by the Board of Supervisors at its regular meeting on March 21, 2023; and, it is further

WHEREAS, upon the recommendation of the County Administrator and the Director of Employment and Training, it has been recommended that the Office of Employment and Training be renamed to the Department of Workforce Development to accurately reflect their mission to develop and maintain a skilled and diverse workforce, and provide employment opportunities and economic sustainability to residents of the County; and

WHEREAS, our Legislative and Government Affairs Committee, the County Administrator and the Director of Human Resources have recommended the foregoing departmental changes; now, therefore be it

RESOLVED, that the Purchasing Department is renamed to the Department of Central Services; and it is further

RESOLVED, that the Department of Employment and Training is renamed to the Department of Workforce Development; and it is further

RESOLVED, that this Resolution shall take effect immediately.

APPROVING AMENDMENTS TO THE BOUNDARIES OF SARATOGA COUNTY CONSOLIDATED AGRICULTURAL DISTRICTS #1 & #2 AND AUTHORIZING ISSUANCE OF A NEGATIVE DECLARATION UNDER SEQRA

WHEREAS, New York State Agricultural and Markets Law Article 25-AA allows landowners with viable agricultural lands to petition the County Board of Supervisors to be included in agricultural districts; and

WHEREAS, pursuant to Resolution 176-96, this Board of Supervisors approved the consolidation of Saratoga County Agricultural Districts #1, 3 and 4 into Saratoga County Consolidated Agricultural District #1 within the Towns of Moreau, Northumberland, Saratoga, Stillwater and Wilton; and

WHEREAS, pursuant to Resolution 133-98, this Board of Supervisors approved the consolidation of Saratoga County Agricultural Districts #2, #5 and #6 into Saratoga County Consolidated Agricultural District #2 within the Towns of Ballston, Charlton, Clifton Park, Galway, Malta, and Milton, and the City of Saratoga Springs, and with continued annual reviews involving Agriculture and Markets Law Section 303-b, has expanded the boundaries of the District within the Towns of Ballston, Charlton, Clifton Park, Corinth, Edinburg, Galway, Greenfield, Hadley, Malta, Milton Providence and the City of Saratoga Springs ; and

WHEREAS, this Board of Supervisors has received a petition from John and Janet Bartow, landowners in the Town of Milton, to include 4.41 ± acres of predominately viable agricultural land located on Middleline Road, identified as Tax Parcel #176.-1-21.11, which parcel is dedicated to beekeeping and vegetable garden, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Susan D. Beck, in the Town of Milton, Tax Parcel #: 162.-1-12 to include 154 ± acres of predominately viable agricultural land located on Emigh Road, which parcel is dedicated to raising cattle and field crops, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Renee and Michael Boel, landowner in the Town of Clifton Park, to include 7.3 ± acres of predominately viable agricultural land located on Tanner Road, identified as Tax Parcel #264.-3-40.111, which is dedicated to production flowers and garden vegetables, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Phil and Dorothy Carrico, in the Town of Greenfield, Tax Parcel #: 139.-1-1 to include 80.31 ± acres of predominately viable agricultural land located on Wilton Road, which parcel is dedicated to raising chickens, alpacas and forestry production, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Lois and Traci DeRidder, in the Town of Wilton, Tax Parcel #'s: 102.-1-90 & 102.-1-99.1 to include a combined 159 ± acres of predominately viable agricultural land located on Blanchard Road, which parcels are dedicated to raising of livestock with expansion of farmland and crop production, within the boundaries of Saratoga County's Consolidated Agricultural District #1; and

WHEREAS, this Board of Supervisors has received a petition from Aaron Llyod, in the Town of Milton, Tax Parcel #: 189.-3-108 to include 16.7 ± acres of predominately viable agricultural land located on Rock City Road, which parcel is dedicated to raising chicken and bees and production of maple syrup and firewood, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Cody and Kateri Sargen, in the Town of Greenfield, Tax Parcel #: 150.-1-9.11 to include 22 ± acres of predominately viable agricultural land located on North Creek Road, which parcel is dedicated to raising livestock for fiber, meat and dairy, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Mathew and Jessmyn Schwartz, in the Town of Milton, Tax Parcel #: 176.-1-75 to include 28.17± acres of predominately viable agricultural land located on Middleline Road, which parcel is dedicated to raising pigs, chickens, goats ducks, vegetables, mushrooms and orchard trees, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Eric and Noelle Smassanow, in the Town of Milton, Tax Parcel #: 215.-1-17 to include 24.29 ± acres of predominately viable agricultural land located on Middleline Road, which parcel is dedicated to raising beef, pork, chickens, turkeys, rabbits, vegetables and fruit, within the boundaries of Saratoga County's Consolidated Agricultural District #2; and

WHEREAS, this Board of Supervisors has received a petition from Susan Veeder, in the Town of Milton, Tax Parcel #: 163.-1-59 to include 12.38 ± acres of predominately viable agricultural land located on Murray Road, which parcel is dedicated to raising chickens and vegetable garden, within the boundaries of Saratoga County’s Consolidated Agricultural District #2; and

WHEREAS, the Saratoga County Agricultural & Farmland Protection Board has submitted a report to the Board of Supervisors recommending the inclusion of the respective lands of Louis and Traci DeRidder within the boundaries of Saratoga County Consolidated Agricultural District #1 and the inclusion of the respective lands of John and Janet Bartow, Susan D. Beck, Renee and Michael Boel, Phil and Dorothy Carrico, Aaron Lloyd, Mary Ann Morgan, Jason O’Donnell, Cody and Kateri Sargen, Mathew and Jessmyn Schwartz, Eric and Noelle Smassanow and Susan Veeder within the boundaries of Saratoga County Consolidated Agricultural District #2; and

WHEREAS, pursuant to Agriculture and Markets Law §303-b (3) and Resolution 44-2023, this Board of Supervisors held a public hearing on March 15, 2023 to consider the petitions for inclusion and the recommendations of the Saratoga County Agricultural and Farmland Protection Board, at which public hearing there were no objections raised to said petitions; and

WHEREAS, the proposed modifications of Saratoga County Consolidated Agricultural Districts #1 & #2 (“Project”) are an Unlisted Action subject to the requirements of the State Environment Quality Review Act (SEQRA) pursuant to 6 NYCRR Part 617; and

WHEREAS, the Saratoga County Board of Supervisors has reviewed the proposed Project, as well as Parts 1, 2 and 3 of a Short Environmental Assessment form prepared for the Project and the proposed responses thereto; now, therefore, be it

RESOLVED, that based upon the Project as proposed and the responses set forth in Parts 2 and 3 of the Short Environmental Assessment form prepared for the Project, the Saratoga County Board of Supervisors hereby determines that the Project will not have a significant impact upon the environment; and it is further

WHEREAS, due to settlement of certain lawsuits, the County of Saratoga received funds to be utilized for opioid remediation to address the misuse and abuse of opioid products, to treat or mitigate opioid use or related disorders, or mitigate other alleged effects of the opioid epidemic, including, but not limited to utilization of naloxone or other FDA-approved drugs to reverse opioid overdoses; evidence-based data collection, and research analyzing the effectiveness of the abatement strategies within the state; and

WHEREAS, the Saratoga County Department of Health (DOH), will increase availability and distribution of naloxone with a naloxbox program, evaluate the cost-effectiveness of non-emergent medical transportation for substance use treatment, and purchase of a mass spectrometer which will integrate surveillance data into the County's Substance Use Surveillance System, which will be displayed on the County Dashboard and shared with community-based organizations with these authorized opioid funds; and

WHEREAS, in New York State there are approximately 8,000 people waiting for an organ transplant; with more than 1,100 New Yorkers having been waiting more than five years for an organ transplant; and an estimated 500 New Yorkers dying every year while waiting for an organ transplant; and

WHEREAS, more than 3,396 transplants were performed in New York State in 2022; and

WHEREAS, New York State's County governments play a key role in raising awareness of the need for organ and tissue donation through the interactions County officials have with the public with regard to this subject through local DMV offices, local boards of elections, departments of health, naturalization ceremonies and veterans' programs; and

WHEREAS, such interactions by Saratoga County officials with the public provide opportunities for the provision of information on how individuals can help their fellow New Yorkers by signing up as organ and tissue donors; and

AUTHORIZING THE TRANSFER OF THE JOSEPH P. DWYER VETERANS PEER TO PEER SUPPORT PROGRAM BETWEEN THE VETERANS SERVICES AGENCY AND THE DEPARTMENT OF MENTAL HEALTH AND ADDICTION SERVICES, AND AMENDING THE 2023 COUNTY BUDGET IN RELATION THERETO

Background is composed of a squad of unarmed solders marching, and backdrop shows the mountain ranges to the east. A complete circle of tiny cannon balls rings this picture, and the words "Saratoga County 1791" appear outside the cannon balls and inside an endless rope circle completing the seal; and

WHEREAS, our Law and Finance Committee and the County Clerk recommend that the new design of the County seal, as hereto attached, be adopted; now, therefore, be it
