AUTHORIZING THE CONVEYANCE OF TAX-ACQUIRED LANDS TO THE TOWN OF GREENFIELD

WHEREAS, unpaid taxes resulted in the County's acquisition of Tax Parcel #162.8-1-18 in the Town of Greenfield pursuant to Article 11 of the Real Property Tax Law; and; and

WHEREAS, Tax Parcel #162.8-1-18 is scheduled to be sold during the County online auction of tax-acquired properties from March 13, 2023 to March 24, 2023; and

WHEREAS, Tax Parcel #162.8-1-18 is a 0.62± acre parcel located on Middle Grove Road in the Town of Greenfield immediately adjacent to the Town's Middle Grove Park; and

WHEREAS, pursuant to Resolution #55 - 2023 of the Greenfield Town Board, the Town of Greenfield submitted an offer to purchase Tax Parcel #162.8-1-18 for the municipal purpose of expanding the size of the Town's Middle Grove Park located at 426 Middle Grove Road; and

WHEREAS, the Town of Greenfield has duly notified the previous owner of Tax Parcel #162.8-1-18 of the Town's offer to purchase the parcel, and the former owner has failed to submit a repurchase offer for the property; and

WHEREAS, it is the policy of this Board to allow the sale of tax-acquired land to a municipality for the amount of all delinquent taxes, penalties and interest owed on the property; and

WHEREAS, our Real Property Tax Committee and the Saratoga County Tax Enforcement Officer recommend the acceptance and approval of the offer of the Town of Greenfield to purchase Tax Parcel #162.8-1-18 for the amount of all delinquent taxes, penalties and interest; now, therefore, be it

RESOLVED, that Tax Parcel #162.8-1-18 (Item 16) is hereby removed from the list of parcels scheduled for auction by the County from March 13, 2023 to March 24, 2023; and it is further

RESOLVED, that the Chair of the Board is hereby authorized to execute and cause to be delivered to the Town of Greenfield at Greenfield Town Hall, 7 Wilton Road, Greenfield Center,

New York, 12833 a quit claim deed conveying Tax Parcel #162.8-1-18 to the Town; and, it is further

RESOLVED, that this conveyance is subject to all current 2023 taxes due and owing on the property, the payment of which taxes shall be the responsibility of the Town of Greenfield; and, it is further

RESOLVED, that this conveyance is subject to 2024 taxes due and owing on the property because the offer to purchase was made after the taxable status date of March 1, 2023, and the payment of these taxes shall be the responsibility of the Town of Greenfield; and, it is further

RESOLVED, that the deed of conveyance from the County to the Town shall include and be subject to the following terms and conditions: 1) the granting of a right of first refusal to the County of Saratoga to purchase the property, for the same amount paid to the County by the Town, in the event the Town ceases to use the property for municipal purposes; and 2) the retention of an easement over the property for the County's municipal purposes; and it is further

AMENDING RESOLUTION 296-2021, AUTHORIZING AMENDMENTS TO MENTAL HEALTH CONTRACTS TO INCLUDE A STATE-FUNDED FULL MARKET RATE STIPEND FOR SUPPORTED HOUSING BEDS, AND AMENDING THE 2023 COUNTY BUDGET IN RELATION THERETO

WHEREAS, Resolution 296-2021, as amended by Resolution 74-2022, 75-2022, 201-2022, 200-2022, and 76-2023 authorized ongoing contracts for mental health services, subject to State appropriations therefor; and

WHEREAS, Resolution 296-2021 further authorized the Health and Human Services Committee to accept additional grant funds from the State of New York in support of the Services to be rendered by the contracting agencies listed in Resolution 296-2021, provided the additional grant funds did not exceed 10% of the contract amounts set forth in Resolution 296-2021; and

WHEREAS, additional funds have become available from New York State Office of Mental Health (“OMH”) in the amount of \$45,144, for a full market rate stipend of \$1,056 per bed stipend for fifty seven (57) supported housing beds, effective April 1, 2023, allocated to the following mental health service providers contractually retained pursuant to Resolution 296-2021:

AUTHORIZING AN AGREEMENT WITH WLADIS LAW FIRM, PLLC FOR THE PROVISION OF PROFESSIONAL LEGAL SERVICES

WHEREAS, Saratoga County Department of Health is transitioning to a Full-Service Health Department, and such transition requires extensive and specialized legal representation including regulatory, grant administration, compliance and licensing components; and

WHEREAS, the County previously entered into a contract with Wladis Law Firm, PLLC for professional legal services related to specialized and general matters including the Department of Health's transition to a full-service health department, projects related to COVID-19 Pandemic response including Emergency Rental Assistance grant programs and Mass Vaccination site projects; and

WHEREAS, the Wladis Law Firm, PLLC has demonstrated exceptional quality of legal services rendered; and

WHEREAS, the Wladis Law Firm has submitted a Letter of Engagement dated March 29, 2023, for additional legal services to provide legal counsel related to general and specialized legal matters, including, but not limited to assisting the Department of Health with its transition to a Full-Service Local Health Department; and other subject matters as needed and requested for the term April 19, 2023 through April 18, 2025 at the rate of \$325 per hour for services provided by firm partners, \$250 per hour for services provided by firm associates, and \$125 per hour for services provided by paralegal staff; reimbursement for mileage and tolls; with standard hourly rates to be adjusted yearly; and

WHEREAS, the Health and Human Services Committee and the Commissioner of the Department of Health have recommended that the County enter into an agreement with Wladis Law Firm, PLLC for professional legal services; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Wladis Law Firm, PLLC of Syracuse, New York, for professional legal services related to general and specialized legal matters, including, but not limited to assisting the County's Department of Health with its transition to a Full-Service Local Health Department; and other subject matters as needed and requested for the term of two (2) years commencing April 19, 2023 and continuing through April 18, 2025 at the rate of \$325 per hour for services provided by firm partners; \$250 per hour for services provided by firm associates; \$125 per hour for services provided by paralegal staff; and reimbursement for mileage and tolls; with standard hourly rates to be adjusted yearly; and, be it further

AUTHORIZING MILEAGE REIMBURSEMENT FOR PARENTS/GUARDIANS WHO PROVIDE TRANSPORTATION FOR CHILDREN ATTENDING PRESCHOOL AND EARLY INTERVENTION CENTER-BASED PROGRAMS

WHEREAS, Saratoga County Department of Health administers New York State’s (“NYS”) mandated Early Intervention and Preschool Special Education Program for children birth to 5 years of age with special needs; and

WHEREAS, pursuant to Education Law §4410 and Public Health Law §2559a, the County is responsible for transporting children who are eligible to receive services either through Early Intervention or Committee on Preschool Special Education and attend center-based programs; and

WHEREAS, as an alternative, parents/guardians are encouraged to provide transportation for students attending center-based programs, and parents/guardians are reimbursed for transportation to such programs; and

WHEREAS, the State of New York (State) 2024 State Budget currently includes in the Executive Budget, Part M, adding section 989 of the Article VII Revenue Bills, and Assembly bill A.5607 (collectively “Proposed Legislation”); and

WHEREAS, the Proposed Legislation would fundamentally alter the foreclosure process under Real Property Tax Law, and misrepresents the reason counties foreclose on and auction tax delinquent properties; and

WHEREAS, the Proposed Legislation requires counties to return excess funds received from the auction to the prior property owner after payment of delinquent taxes, administrative costs incurred by the enforcing officer, and identifying and paying all other lienholders and claims against the property; and

WHEREAS, the Proposed Legislation contains ambiguous language regarding allowable administrative costs, fails to address the liability incurred by counties for distribution of excess funds, and lacks any funding for additional staff and other expenses incurred by counties necessary to comply with the Proposed Legislation mandate; and

WHEREAS, the Proposed Legislation is premature given the case pending before the U.S. Supreme Court, which is scheduled for oral argument on April 26, 2023, which may provide necessary guidance for appropriate changes to the existing State Real Property Tax Law; and

WHEREAS, the Saratoga County Board of Supervisors strongly disagree with State’s Proposed Legislation; and now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors requests the Governor to remove in the 2024 State Executive Budget, Part M, adding section 989 of the Article VII Revenue Bills; and it is further

AMENDING THE COUNTY INVESTMENT POLICY TO ADD AUTHORIZED COOPERATIVE INVESTMENT AGREEMENTS AND TO UPDATE MAXIMUM BANK DEPOSIT LIMITS

WHEREAS, Resolution 237-2018 amended and restated the Comprehensive Investment Policy of the County of Saratoga (“County Investment Policy”); and

WHEREAS, Resolution 134-2019 amended the County Investment Policy to authorize the County Treasurer to invest in cooperative investment agreements and to add the New York Cooperative Liquid Asset Securities System (“NY Class”) as an authorized cooperative investment agreement; and

WHEREAS, New York General Municipal Law, Article 5-G, Section 119-o, empowers municipal corporations (defined in Article 5-G, Section 119-n, to include school districts, boards of cooperative educational services, counties, cities, towns and villages, and districts) to enter into, amend, cancel, and terminate agreements for the performance amongst themselves (or one for the other) of their respective functions, powers, and duties on a cooperative or contract basis; and

WHEREAS, “cooperative investment agreements” are defined by General Municipal Law §42(1) as “the temporary investment of moneys by more than one municipal corporation pursuant to a municipal cooperation agreement entered into in accordance with the provisions of Articles 5-G and 3-A of the General Municipal Law; and

WHEREAS, the County Investment Policy includes limits to the amount of deposits, namely those amounts insured by the Federal Deposit Insurance Act (FDIC), the County Treasurer may hold at certain banks, to limit the County’s exposure to any financial crisis incurred by a bank; and

WHEREAS, the County of Saratoga wishes to assure the safety and liquidity of its funds; and

WHEREAS, increasing the County’s investments in short-term highly liquid investment funds designed specifically for the public sector that are carefully selected to maximize safety and liquidity while generating a competitive yield, provides a mechanism for the County to

reduce its deposits at banking institutions given the recent challenges facing the U.S. banking sector, and the County Treasurer having considered the recent cash flow analysis provided by Three One Company, Inc. and

WHEREAS, pursuant to General Municipal Law, Article 2, Section 10-3, all public deposits in excess of the amount insured under the FDIC, must be secured, and amending the County Investment Policy to update bank deposit limits to include only uninsured deposits, facilitates the County Treasurer's ability to invest County funds in high-yield investments such as Interbank Capital Sweep (ICS) accounts, and

WHEREAS, the County utilizes the Adirondack Trust Company (ATC) as its primary bank, and the current deposit limit at ATC is insufficient, \$50,000,000, to meet the demands of the County for deposits and monthly payments, and an increase in the deposit limit, to \$60,000,000, is necessary for the County Treasurer to transact County business and administer necessary "Accounts Payable"; and

WHEREAS, copies of the proposed amendments to the County Investment Policy have been provided to all members of this Board; and

WHEREAS, this Board, and the County Treasurer have recommended that the Saratoga County Investment Policy be amended as follows: 1) Amend Exhibit A Qualified Banks and Maximum Total Deposit Amounts", as adopted pursuant to Resolution 237 – 2018, to increase the Maximum Total **Uninsured** Deposit Amount to **\$60,000,000** from \$50,000,000 for The Adirondack Trust Company and add **JPMorgan Chase & Co.** with a Maximum Total **Uninsured** Deposit Amount of **\$40,000,000** 2) "Exhibit C", as adopted pursuant to Resolution 134 – 219; to add **NYLAF – New York Liquid Asset Fund and NY MuniTrust Local Government Investment Pool** to the list of authorized Cooperative Investment Agreements; and 3) **that the Saratoga County Treasurer is hereby designated as Key Contact and authorized to execute and deliver the Municipal Cooperation Agreements with the herein authorized Cooperative Investment Agreements in the name of and on behalf of the County of Saratoga;**
now therefore be it
