The applications for the 2023 Economic Development Grants have been released with a due date of September 15, 2023. The Planning and Economic Development Department reached out to all prior grant recipients for an update on their projects. In addition, the Town of Ballston has initiated their 2023 project which is a sewer feasibility study in the Burnt Hills Business District.

# AUTHORIZING THE TRANSFER OF FUNDS FROM THE ECONOMIC DEVELOPMENT RESERVE FUND AND AMENDING THE 2023 COUNTY BUDGET IN RELATION THERETO

**WHEREAS**, pursuant to Resolution 97-2021, this Board established a capital reserve fund to be known as the "Economic Dev Grant Reserve" for the purpose of depositing unexpended funds for the Municipal Economic Development Assistance Program; and

**WHEREAS**, pursuant to Resolution 97-2021 the reserve account was created to house the unexpended municipal economic grant program funds until such funds are needed, and a reimbursement voucher is submitted by the municipal applicant, at which point the funds will be appropriated to the General Fund budget; and

WHEREAS, the unexpended grant funds from the 20<u>21 City of Saratoga Springs, 2022</u>
Town of Waterford, and 2022 Town of Clifton Park, and 2022 Town of Moreau <u>19 and 2020</u>
Municipal Economic Development Assistance Program total \$49,700124,800; and

**WHEREAS**, various grant projects that were approved in 20<u>21</u><sup>19</sup> and 202<u>2</u><sup>0</sup> have been submitted for payment and reimbursement was approved by our Economic Development Committee; and

**WHEREAS**, the transfer of Economic Development Grant Reserve funds to the Municipal Economic Development Assistance account requires this Board's approval and an associated amendment to the 20232 County budget; and

**WHEREAS**, our Economic Development Committee and the Director of Planning and Economic Development have recommended that \$49,700124,800 be transferred from the Economic Development Grant Reserve funds to the Municipal Economic Development Assistance account; now, therefore, be it

**RESOLVED**, that this Board authorizes the transfer of \$124,800 \$49,700 from the Economic Development Grant Reserve funds to the Municipal Economic Development Assistance account to provide reimbursement to municipal applicants as approved by our Economic Development Committee; and it is further

# **RESOLVED**, that the 202<u>32</u> Saratoga County Budget is amended as follows:
