

Community Development Plan Exits 11-13 Promotion 2023

A potential upgrade opportunity exists for the Clifton Park Information Center, to add an exhibit focused on businesses and attractions between Exits 11-13 and entice travelers off of the Northway. Malta is the next town north of this unique and valuable information center, and yet there is little information available about this community or neighboring towns. The signage for the Saratoga Battlefield is at Exit 12, yet there is no real effort to draw tourists off the Northway to nearby venues at that Exit.

In conjunction, an effort should be made to have coordinated electronic material on display at the various visitor centers (for example using same images for Hudson Crossing Park at the Gateway VC and Clifton Park Info Center)

An additional option (requiring an additional investment TBD) would be to consider making rack cards, electronic promotion material and/or the creation of an "app" to help travelers and newcomers find the various visitor centers located in Saratoga County, both large and small: Clifton Park Info Center, Gateway Visitor Center, Mechanicville city docks bulletin board, Saratoga Springs Visitor Center, Stillwater Blockhouse Visitor Center, Waterford Harbor Visitor Center and others

ECONOMIC IMPACT: The info center at the Exit 9 Rest Area places Saratoga County information in front of 200,000-250,000 people each year. Traffic remains very high at that location, this county's only dedicated connection to the I-87 corridor. The Saratoga Battlefield is accessible through Exit 12 and is one of our national historic treasures and a revenue generator for our communities and County.

New, coordinated Saratoga County promotion materials

It is a stated priority that area visitor centers such as the new Gateway Visitor Center in Schuylerville are designed along the hub/spoke model to direct visitors out into the various communities. An expansion of this idea would be to join the hubs and spokes together, similar to the trucks on a train undercarriage. With coordination across visitor centers, common information can be shared across the county, so that if one finds one of our visitor centers, they find them all.
