AUTHORIZING THE CONVEYANCE OF A TAX-ACQUIRED PARCEL IN THE TOWN OF DAY

WHEREAS, pursuant to Resolution 206-10, this Board, on the advice of the Tax Enforcement Officer, declared Tax Parcel 24.-2-26 in the Town of Day “worthless” in accordance with Real Property Tax Law (RPTL) § 1138 which resulted in all delinquent, current and prospective taxes being canceled on said tax parcel; and

WHEREAS, in accordance with RPTL § 1138(6) the Saratoga County Tax Enforcing Officer filed a Certificate of Prospective Cancellation on November 18, 2010 with the Saratoga County Clerk’s Office, the assessor of the assessing unit, and with the Director of Real Property Tax Services canceling all delinquent, current and prospective taxes on said tax parcel; and

WHEREAS, Mr. Leonard Allen of Hadley, New York has expressed a desire to purchase tax parcel 24.-2-26; and

WHEREAS, our Real Property Tax Committee has reviewed the status of Tax Parcel 24.-2-26 and deems it in the best interest of all taxing jurisdictions to sell the parcel to Mr. Allen and have it placed back on the tax rolls; and

WHEREAS, all proposed conveyances of County lands require the approval of this Board; now, therefore, be it

RESOLVED, that the Chair of the Board convey by quitclaim deed Tax Parcel 24.-2-26 in the Town of Day to Leonard Allen of Hadley, New York for the sum of Twenty-Five Dollars (\$25.00) and the cost of filling the deed in the Saratoga County Clerk’s Office; and it is further

RESOLVED, that this Resolution shall take effect immediately.

CANCELLING TAXES IN THE TOWN OF BALLSTON

WHEREAS, Tax Parcel 257.10-2-55 is located at 814 Saratoga Road, Burnt Hills, New York 12027 (“Magnum Property”) that was previously used as a gas station and auto mechanic shop that had extensive environmental contamination; and

WHEREAS, there were risks for the County to acquire the Magnum Property within a tax foreclosure process due to liability associated with the costs to remediate the environmental contamination present at the site; and

WHEREAS, pursuant to Resolution 57-2022 this Board recognized those inherent risks when it authorized the County to enter into agreements with the New York Environmental Protection and Spill Compensation Fund (“Spill Fund”) and the Town of Ballston to facilitate the remediation of the environmental contamination on the Magnum Property; and

WHEREAS, said agreements allow the Town to acquire the Magnum Property in exchange for a payment of \$7,000 to the Spill Fund, and in turn the Spill Fund would release the County of Saratoga from potential claims for cleanup and removal costs incurred by the State at the Magnum Property; and

WHEREAS, the agreements will enable future public use of the site and provide a benefit to the County of Saratoga by the avoidance of incurring the high costs of remediating the site, but the agreements did not account for the payment of outstanding taxes currently due on the Magnum Property; and

WHEREAS, it is necessary for the County to cancel delinquent, current and prospective taxes on the subject property for the agreements to move forward;

WHEREAS, the Magnum Property has delinquent taxes for the years 2018 – 2023 totaling \$38,729.86; and

WHEREAS, pursuant to Real Property Tax Law § 1138[1][d], a taxing district may cancel a delinquent tax lien if the taxing district were to acquire the parcel, there is a significant risk that it might be exposed to a liability substantially in excess of the amount that could be recovered by enforcing the tax lien; and

WHEREAS, this Board’s Real Property Tax Committee and Saratoga County’s Tax Enforcing Officer recommend that the delinquent, current and prospective taxes on the Magnum Property be cancelled; now, therefore, be it

RESOLVED, that the following delinquent tax liens on the following parcel are hereby cancelled pursuant to Real Property Tax Law § 1138:

OPPOSING PASSAGE OF CONSERVATION SUBDIVISION DESIGN BILL A04608 AND CORRESPONDING SENATE BILL

WHEREAS, bill number A04608 has been introduced in the New York State Assembly, and the bill would require residential subdivisions within the Adirondack Park that meet lot size thresholds to comply with conservation design criteria that are more stringent than current residential subdivision requirements; and

WHEREAS, the proposed legislation would affect property with acreage as low as 3.2 acres and mandates private property owners to incur undue financial burdens by hiring consultants to complete ecological evaluations, assessments and concept plans and will also add considerable time to proposed developments; and

WHEREAS, the proposed legislation could eliminate the potential for development on certain lands constituting a “taking” without just compensation when current laws, regulations and policies already protect and regulate private lands in the park; and

WHEREAS, the agency mandated by law to regulate private lands in the Adirondack Park, the Adirondack Park Agency, has already adopted a Large-scale Subdivision Application program that incorporates many of the same action items in the proposed Conservation Subdivision Design Bill; and

WHEREAS, implementation of the Adirondack Park Agency Large-scale Subdivision Application is arguably more protective of environmental resources than the Conservation Subdivision Design Bill allows for; and

WHEREAS, there are more than 3.3 million acres of a 5.9 million-acre Adirondack Park that will never be developed or subdivided; and

WHEREAS, of the remaining 2.6 million acres of private land, existing development, roads, lakes, rivers, streams, steep slopes, wetlands and high elevations are not suitable for development; and

WHEREAS, the proposed legislation would amend the existing Adirondack Park Agency Act which has been in effect for 50 years; and

WHEREAS, the Adirondack Park Agency, without any conditions or parameters outlined in the law, will be charged with undertaking site evaluations and the authority to propose additional conditions vaguely allowed in the law incident to the development of property and ecological issues; and

WHEREAS, the proposed Bill places an additional burden on property owners within the Adirondack Park which is not necessary to protect the environment and ecological systems and is not beneficial to the well-being of the Adirondack Park and its residents; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors does not approve of the proposed Bill; and it is further

RESOLVED, that the Saratoga County Board of Supervisors does hereby call upon local governments to stand together, individually and through its associations to insist that the Conservation Subdivision Design Bill A04608 be withdrawn; and it is further

WHEREAS, pursuant to Resolutions 156-2018, 167-2018, 187-2020, 200-2021, and 259-2022 this Board authorized the execution of agreements with the following school districts for the provision of School Resource Officer services: Ballston Spa Central School District, Burnt Hills-Ballston Lake Central School District, Corinth Central School District, Galway Central School District, Mechanicville City School District, Schuylerville Central School District, South Glens Falls Central School District, Stillwater Central School District, Shenendehowa Central School District, and Saratoga Springs City School District for the assignment of Saratoga County Sheriff's Department Road Patrol Deputies as School Resource Officers; and

WHEREAS, the Waterford-Halfmoon Union Free School District wishes to enter into an agreement for the provision of a Saratoga County Sheriff's Department Road Patrol Deputy to serve in the capacity of a School Resource Officer for the School District for the remainder of the school year commencing April 17, 2023 until June 30, 2023 at a cost of \$15,712.47; and

WHEREAS, as the School Resource Officer, the duties of the assigned Deputy will include, but not be limited to: maintaining a presence on the assigned school campus directed towards protecting the safety and well-being of students and school staff; reducing disorder and student crime; assisting school personnel with truancy related issues; teaching and/or making classroom presentations to students and school personnel on such issues as violence prevention, substance abuse prevention, social conflict resolution, and school safety; responding to life or safety threatening emergencies; and

WHEREAS, our Public Safety Committee and the Sheriff have recommended the County enter into an agreement with the Waterford-Halfmoon Union Free School District for the provision of a single Road Patrol Deputy to serve as School Resource Officer for the Waterford-Halfmoon Union Free School District commencing April 17, 2023 until June 30, 2023, at a cost of \$15,712.47; now, therefore, be it

RESOLVED, that the 2023 Compensation Schedule under the Sheriff's Department shall be amended to add one (1) additional position under Deputy-Sheriff-Patrol to meet the obligation of the agreement; and it is further

RESOLVED, that the one (1) additional position shall remain in effect for the duration of a contract with the Waterford-Halfmoon Union Free School District and only eliminated through attrition thereafter; and it is further

RESOLVED, that the Chair of the Board and the Sheriff are hereby authorized to execute an agreement with Waterford-Halfmoon Union Free School District for the term commencing April 17, 2023 until June 30, 2023 for the provision of a single Road Patrol Deputy to serve as School Resource Officer at a cost of \$15,712.47, to cover the school district's approximate pro-rata share of the County's employee, transportation, equipment and patrol car costs for the assigned Deputy; and be it further

RESOLVED, that the foregoing agreement with Waterford-Halfmoon Union Free School District shall provide that upon the request of the school district and the approval of the Saratoga County Sheriff, Saratoga County Sheriff's Department Road Patrol Deputies shall be authorized to provide overtime security services at school activities and events outside of normal school hours at an additional cost to the school district of \$50.00 per hour for a minimum of two (2) hours per school activity/event; and, be it further

RESOLVED, that contract costs for any renewal period for the 2023-2024 or 2024-2025 school years shall be the school district's approximate pro-rata share of the County's employee, transportation, equipment and patrol car costs for each assigned Deputy, as calculated by the Saratoga County Sheriff by no later than June 1 prior to the commencement of that school year; and be it further

AUTHORIZING AN AGREEMENT WITH EMERGENCY POWER SYSTEMS, LLC FOR PREVENTIVE MAINTENANCE SERVICES FOR THE EMERGENCY STAND-BY GENERATORS AT THE COUNTY'S PUBLIC SAFETY RADIO TOWERS

WHEREAS, the Director of Emergency Management solicited bids for quarterly preventive maintenance services for the emergency stand-by generators at the County's Public Safety 800 MHz radio towers; and

WHEREAS, our Public Safety Committee and the Director of Emergency Management have recommended that the bid of Emergency Power Systems, LLC in the amount of \$16,400 per year plus additional costs for emergency site visits and repair, the lowest bid received, for quarterly preventive maintenance services for the emergency stand-by generators at the County's Public Safety 800 MHz radio towers be accepted; now, therefore, be it

AUTHORIZING AGREEMENTS WITH W.M. SCHULTZ CONSTRUCTION, INC. FOR HVAC AND PLUMBING UPGRADES TO THE SARATOGA COUNTY SEWER DISTRICT NO. 1'S SARATOGA SPRINGS PUMP STATION, AND AMENDING THE 2023 COUNTY BUDGET IN RELATION THERETO

WHEREAS, Resolution 246-2020 authorized an agreement with Weston & Sampson, PE, LS, LA, PC (“Weston & Sampson”) for evaluation and design of upgrades to the Saratoga County Sewer District No. 1’s Saratoga Springs pump station; and

WHEREAS, the Saratoga Springs pump station is in need of rehabilitation and improvement, as described in the December 2021 report prepared by Weston & Sampson; and

WHEREAS, the Sewer District and their consulting engineers have previously determined that the upgrades to the Saratoga Springs pump station is a “Type II Action” under the State Environmental Quality Review Act, requiring no further review thereunder; and

WHEREAS, the Sewer District currently has a contract for general construction of the upgrades at the Saratoga Springs Pump Station; and

WHEREAS, an HVAC contract and plumbing contract are necessary to provide a fully rebuilt pump station to enable the Saratoga Springs Pump Station to serve the entire Town of Wilton, and a large majority of the City of Saratoga Springs; and

BOND RESOLUTION AUTHORIZING THE ISSUANCE OF AN ADDITIONAL \$16,650,000 SERIAL BONDS OF THE COUNTY OF SARATOGA, OR SO MUCH THEREOF AS MAY BE NECESSARY TO FINANCE THE COST OF CONSTRUCTION OF A BIOSOLIDS DIGESTER FACILITY BY SARATOGA COUNTY SEWER DISTRICT NO. 1

WHEREAS, the County Board of Supervisors of the County of Saratoga, New York on August 17, 2021 adopted Resolution 238-2021, a Bond Resolution (the “Prior Bond Resolution”) entitled “BOND RESOLUTION AUTHORIZING THE ISSUANCE OF \$51,900,000 BONDS OF THE COUNTY OF SARATOGA, OR SO MUCH THEREOF AS MAY BE NECESSARY, TO FINANCE THE COST OF CONSTRUCTION OF A BIOSOLIDS DIGESTER FACILITY BY SARATOGA COUNTY SEWER DISTRICT NO. 1; STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$51,900,000, STATING THE PLAN OF FINANCING; PROVIDING FOR A TAX TO PAY THE PRINCIPAL OF AND INTEREST ON SAID BONDS; AND PROVIDING FOR REIMBURSEMENT BY SARATOGA COUNTY SEWER DISTRICT NO. 1 TO SAID COUNTY”; and

WHEREAS, the County Board of Supervisors wishes to (i) authorize the expenditure and appropriation of additional funds in connection with the reconstruction of the Saratoga County Sewer District No. 1 (the “District”) facilities in order to construct a Biosolids Digester Facility, and the acquisition of land or rights in land and acquisition of original furnishings, equipment, machinery or apparatus required in connection therewith (the “Project”); and (ii) authorize the issuance of additional serial bonds of the County to finance such additional appropriation; now therefore be it

RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF SARATOGA, NEW YORK (by the affirmative vote of not less than two thirds of the voting strength of said Board), AS FOLLOWS:

Section 1. The County of Saratoga, New York (herein called “County”), is hereby authorized to undertake the Project at an estimated maximum cost not to exceed \$68,550,000, constituting an increase of \$16,650,000 over the amount previously authorized in the Prior Bond Resolution.

Section 2. The plan for financing such new maximum authorized cost of \$68,550,000 shall be as follows:

(a) By the issuance of \$51,900,000 of Serial Bonds of the County heretofore authorized to be issued pursuant to the Prior Bond Resolution; and

(b) By the issuance of an additional \$16,650,000 of Serial Bonds (the “Bonds”) of the County authorized to be issued pursuant to this Resolution.

Section 3. It is hereby determined that the period of probable usefulness for the specific object or purpose is forty (40) years pursuant to paragraph 4 of Section 11.00(a) of the Local Finance Law; provided, however, that the maximum maturity of the Bonds authorized shall be computed from the date of issuance of (a) the Bonds or the first bond anticipation note issued in anticipation of the Bonds authorized pursuant to this Resolution or (b) the bonds or bond anticipation notes authorized pursuant to the Prior Bond Resolution, whichever date is earlier.

Section 4. Pursuant to Section 107.00(d)(9) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.

Section 5. The temporary use of available funds of the County, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this resolution.

Section 6. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the County, payable as to both principal and interest by a general tax upon all the real property within the County without legal or constitutional limitation as to rate or amount. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be assessed and levied upon the real property of users connected to the District’s sewer system, in accordance with the District’s annual scale of charges for the collection, conveyance, treatment and disposal of sewage and wastewater from public corporations, improvement districts, commercial and industrial users and individuals, as such scale of charges currently exists and as it will be amended and adopted on an annual basis, an amount sufficient to pay the principal of and interest on such obligations as the same become due and payable, but if not paid from such source, all the taxable real property in the County shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal and interest on such obligations when due. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

Section 7. Subject to the provisions of this resolution and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00, inclusive, of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to issue bonds providing for level or substantially level or declining annual debt service, is hereby delegated to the County Treasurer, the Chief Fiscal Officer of the County.

Section 8. This resolution is intended to constitute the declaration of the County's "official intent" to reimburse the expenditures authorized by this resolution with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by Regulation Section 1.150-2. Other than as specified in this resolution, no moneys are reasonably expected to be, received, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

Section 9. The serial bonds and bond anticipation notes authorized to be issued by this resolution are hereby authorized to be consolidated, at the option of the County Treasurer, the Chief Fiscal Officer, with the serial bonds and bond anticipation notes authorized by other bond resolutions previously or heretofore adopted by the Board of Supervisors of the County for purposes of sale in to one or more bond or note issues aggregating an amount not to exceed the amount authorized in such resolutions. All matters regarding the sale of the bonds, including the dated date of the bonds, the use of electronic bidding, the consolidation of the serial bonds and the bond anticipation notes with other issues of the County and the serial maturities of the bonds are hereby delegated to the County Treasurer, the Chief Fiscal Officer of the County.

The County Treasurer, as chief fiscal officer of the County, is further authorized to sell all or a portion of the Bonds and bond anticipation notes to the New York State Environmental Facilities Corporation ("EFC"); to execute and deliver on behalf of the County one or more Loan Agreements, Project Financing Agreements, and Letters of Intent with EFC and to accept the definitive terms of one or more Loan Agreements from EFC by executing and delivering one or more Term Certificates; and to execute such other documents, and take such other actions, as are necessary or appropriate to obtain a loan or loans from EFC for all or a portion of the costs of the expenditures authorized by this Bond Resolution, and perform the County's obligations under its Bonds and bond anticipation notes delivered to EFC, the Project Financing Agreements and the Loan Agreements.

Section 10. The validity of the Bonds authorized by this resolution and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:

(a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money; or

(b) the provisions of law which should be complied with at the date of the publication of this resolution or a summary hereof are not substantially complied with, and an action, suit or

proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

(c) such obligations are authorized in violation of the provisions of the Constitution.

Section 11. The County Treasurer, as Chief Fiscal Officer of the County, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the County to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12, as amended.

Section 12. This resolution, or a summary of this resolution, shall be published in the official newspapers of the County for such purpose, together with a notice of the Clerk of the County in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 13. This resolution is not subject to a mandatory or permissive referendum.

Section 14. The Board of Supervisors of the County hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this resolution.

Section 15. This resolution shall take effect immediately upon its adoption.

AMENDING AND APPROVING THE PROPOSED CONSTRUCTION OF A BIOSOLIDS DIGESTER FACILITY BY SARATOGA COUNTY SEWER DISTRICT NO. 1 AND ADOPTING A NEGATIVE DECLARATION UNDER SEQR

WHEREAS, by proceedings heretofore duly had and taken pursuant to Article 5-A of the County Law, the Board of Supervisors of Saratoga County, New York, has established a county sewer district designated and known as Saratoga County Sewer District No. 1, in said County (the "District"); and

WHEREAS, for a variety of technical and financial reasons, the District was unable to comply with new federal Title V air regulations pertaining to the incineration of sludge/biosolids at the District's Wastewater Treatment Plant, and as a consequence thereof, terminated operations of the Plant's sludge incinerator on March 20, 2016; and

WHEREAS, as a result of ceasing operations of its sludge incinerator, the District had to retain the services of a commercial hauler to remove, transport and dispose of sludge/biosolids from its Treatment Plant; and

WHEREAS, a feasibility study has been completed by Arcadis of New York, Inc., reviewed by the members of the District Commission and filed with the Board of Supervisors pursuant to Section 268 of the County Law in relation to a proposed increase and improvement of the facilities of said District; and

WHEREAS, the construction of a biosolids management facility at Saratoga County Sewer District No. 1's wastewater treatment plant (the "Project") is necessary to ensure the long-term stability in the management and treatment of biosolids; and

WHEREAS, the biosolids facility currently proposed will utilize anaerobic digestion and a dryer to reduce volume, produce a Class A biosolids product for land application, and the biogas produced will be cleaned and potentially used as Renewable Natural Gas injected into the common utility owned pipeline; and

WHEREAS, following the public hearing held on August 17, 2021, the Board of Supervisors previously determined, pursuant to Resolution 237-2021 adopted August 17, 2021, that it is in the public interest of the people of the County of Saratoga residing within the

boundaries of the District to undertake the Project at a maximum estimated cost of \$51,900,000, with an annual net cost to the typical property in the District as a result of the Project previously estimated to be \$5.08; and

WHEREAS, due to price increases and uncertainty in the bid market, the estimated maximum cost of the Project has increased from \$51,900,000 to \$68,550,000, and the estimated annual net cost to the typical property in said District as a result of such costs would increase from \$5.08 to an \$6.67; and

WHEREAS, the new design would add a new dryer facility, concrete tanks, and other equipment decisions which will allow for operational flexibility and value over the life of the equipment; and

WHEREAS, pursuant to Resolution 117-2023, this Board set a time for the holding of a public hearing on said increase and improvement of facilities in accordance with the feasibility study and estimate of cost; and

WHEREAS, pursuant to Resolution 117-2023, this Board authorized and directed the Clerk of the Board of Supervisors to publish the notice of public hearing and file a certified copy of such notice with the office of the State Comptroller; and

WHEREAS, said public hearing was duly held at the Chambers of the Saratoga County Board of Supervisors, 40 McMaster Street, in the Village of Ballston Spa, New York, in Saratoga County, on May 10, 2023, at 4:30 p.m.; and

WHEREAS, notice of said public hearing was duly published and filed in the manner provided by law and proof thereof was submitted to said Board of Supervisors; and

WHEREAS, the Saratoga County Board of Supervisors wishes to continue to reduce the volume and mass of biosolids not being utilized as a renewable gas source; and

WHEREAS, the Saratoga County Board of Supervisors proposes to address this issue by constructing a biosolids management facility that consists of sludge thickening and anaerobic digestion followed by dewatering and thermal drying in a sludge dryer, where biosolids will be disposed of by a third-party hauler. Biogas will be stored at lower pressure, conditioned, and introduced into the natural gas grid as renewable natural gas. Excess biogas will be utilized in boilers or flared; and

WHEREAS, the project which will treat 7,230 dry tons of biosolids in the digesters and 4,780 dry tons being dewatered and hauled off site annually, is consistent with the goals and objectives of the Saratoga County Sewer District; and

WHEREAS, the Saratoga County Board of Supervisors recognizes the importance of the Saratoga County Sewer Districts facility and has incorporated advancements in treating waste and utilizing it in a form of renewable energy sources; and

WHEREAS, this project is a Type I action pursuant to the State Environmental Quality Review Act (SEQR) and therefore subject to the implementing regulations of that law found in Part 617 of Title 6 of the Official Compilation of Codes, Rules and Regulations of the State of New York (“6 NYCRR Part 617”); and

WHEREAS, the Saratoga County Board of Supervisors has conducted coordinated review with the involved agencies pursuant to 6 NYCRR § 617.6 and no agencies objected to the Board’s request to act as Lead Agency; and

WHEREAS, the Saratoga County Board of Supervisors has reviewed the potential impacts identified in the Parts 1, 2 and 3 of the Environmental Assessment Form (“EAF”) and as a result has found no significant adverse environmental impacts will occur as a result of the project; and

WHEREAS, it would appear that the construction of said sewer facility improvements would be in the best interests of the people of the County of Saratoga residing within the boundaries of Saratoga County Sewer District No. 1; now, therefore be it

RESOLVED, that the Saratoga County Sewer District No. 1 declared its intent to act as Lead Agency, and the Saratoga County Board of Supervisors shall adopt and file the Negative Declaration in accordance with 6 NYCRR §617.7 and 617.12; and be it further

RESOLVED, that upon the evidence given at the aforesaid public hearing, it is hereby found and determined that it is in the public interests of the people of the County of Saratoga residing within the boundaries of the District to proceed with the expenditure for the District’s cost for construction of said sewer facility improvements, all as more fully described in the preambles hereof, and such increase and improvement of facilities is hereby authorized at a maximum estimated cost of \$68,550,000; and be it further

RESOLVED, the expense of said increase and improvement of facilities shall be financed by the issuance of bonds in an amount not to exceed \$68,550,000 of said County and the costs of said increase and improvement of facilities, including payment of principal of and interest on said bonds, shall be apportioned in accordance with the Sewer District’s annual scale of charges for the collection, conveyance, treatment and disposal of sewage and wastewater from public corporations, improvement districts, commercial and industrial users and individuals, as such scale of charges currently exists and will be amended and adopted on an annual basis, with the expectation that any funds received by the District from New York State grants shall be used to pay a part of the cost of the project or to pay debt service on bonds issued to finance the project or shall be budgeted as an offset to such assessments to be levied and collected; and be it further

RESOLVED, that this Resolution shall take effect immediately.

WHEREAS, the statewide moratorium imposed by the *COVID-19 Emergency Eviction and Foreclosure Act of 2020* resulted in a significant backlog of delinquent tax parcels subject to real property tax foreclosure enforcement by Saratoga County; and

WHEREAS, the County's delinquent tax parcels ripe for tax foreclosure enforcement include tax liens from tax years 2019, 2020, and 2021; and

WHEREAS, title searches are required to identify the owner or owners, and any person or entity that has any right, title, or interest in, the delinquent tax parcels for purposes of serving the tax foreclosure petition upon these parties; and

WHEREAS, the County has concluded the required title searches for the 2019 tax year liens, but has not conducted title searches for the 2020 and 2021 tax year liens; and

WHEREAS, a backlog of title searches for the 2020 and 2021 tax year liens exists; and

WHEREAS, it is in the interest of the County to perform these title searches to initiate tax foreclosures proceedings and return the property to the tax rolls; and

WHEREAS, our Law and Finance Committee, the Director of the Office of Real Property Tax Service, and County Treasurer as the Tax Enforcing Officer, recommend expediting title searches to allow the County to initiate tax foreclosure proceedings on delinquent tax parcels; now, therefore, be it

RESOLVED, that this Board authorize the transfer of \$75,000 to fund multiple minor contracts outsourcing titles searches of delinquent tax parcels for tax years 2020 and 2021; and it is further

RESOLVED, that the Budget Officer is hereby authorized to enter the appropriate journal entries to reflect the approved budget transfer; and it is further
