Public Safety Committee Minutes June 7, 2023 – 2:30 p.m.

Chairman Lant called the meeting to order and welcomed all in attendance.

On a motion made by Mr. Hammond, seconded by Mr. Butler, the minutes of the May 3, 2023 meeting were approved unanimously.

A motion was made by Mr. Tollisen, seconded by Mr. Hammond, to authorize amending Resolution 109-2022 and authorizing an amended agreement with Jacqueline Bashkoff, PH.D. for the provision of expert psychological services. Unanimous.

This agreement will increase from \$20,000 to \$50,000 due to a significant increase in court ordered psychiatric evaluations.

A motion was made by Mr. Tollisen, seconded by Mr. Kevin Veitch, to authorize an agreement with the Prevention Council of Saratoga County Inc. for Certified Recovery Peer Advocate Services at the Saratoga County Correctional Facility. Unanimous.

This agreement will be for a cost not to exceed \$80,000 for 2023, \$40,000 of which is paid by the State.

A motion was made by Mr. Hammond, seconded by Mr. Butler, to authorize an Agreement with the New York State Division of Criminal Justice Services to Accept a 2023 Crimes Against Revenue Program Grant. Unanimous.

This grant amount is in the amount of \$118,900.

A motion was made by Mr. Tollisen, seconded by Mr. Kevin Veitch, to authorize an agreement with Mission Critical Partners, LLC for maintenance of the County Computer-Aided Dispatch System. Unanimous.

This agreement will be effective July 1, 2023 through June 30, 2024 at a cost of \$107,187 for the first year with a three percent increase per year for the next two years.

A motion was made by Mr. Kevin Veitch, seconded by Mr. Butler, to authorize a four year maintenance service agreement with Motorola Solutions, Inc. for maintenance of the County's Public Safety Radio Infrastructure. Unanimous.

This agreement will be effective July 1, 2023 through June 30, 2027 at a cost of \$3,833,160.77.

A motion was made by Mr. Hammond, seconded by Mrs. Raymond, to authorize registration for cooperative purchasing through HGAC and authorizing the transfer of funds for the purchase of a Hazardous Materials Response vehicle. Unanimous.

Mr. Zurlo introduced his new Undersheriff Jeff Brown and new Chief Deputy Pat Maswich.

On a motion made by Mr. Hammond, seconded by Mr. Kevin Veitch, the meeting was adjourned unanimously.
