## RESOLUTION 177- 2023

**Introduced by Real Property Tax: Supervisors Ostrander, Barrett, Edwards, Lawler and Wright**

### **TEMPORARILY REVISING PROJECTED REVENUES FROM THE 2023 REAL PROPERTY TAX FORECLOSURE AUCTION AND AMENDING THE 2023 BUDGET IN RELATION THERETO**

**WHEREAS**, Saratoga County conducted its 2023 real property tax foreclosure auction pursuant to Article 11 of the Real Property Tax Law to foreclose on 2018 tax liens; and

**WHEREAS**, the auction of such real property concluded on March 24, 2023, 2018 tax liens were satisfied, and surplus proceeds were placed into a County Treasurer's Office account in accordance with the Real Property Tax Committee Policies and Procedures Manual; and

**WHEREAS**, on May 25, 2023, the United States Supreme Court issued its decision in *Tyler v. Hennepin County* and held that a taxing jurisdiction's retention of surplus funds from a tax foreclosure proceeding is unconstitutional in violation of the Takings Clause; and

**WHEREAS**, current in rem tax foreclosure laws and practices under New York State Real Property Tax Law Article 11 may conflict with the *Tyler v. Hennepin County* decision; and

**WHEREAS**, in view of the *Tyler v. Hennepin County* decision, the New York State Legislature passed legislation proposing to implement a state-wide moratorium on the conveyance of tax delinquent parcels acquired for delinquent taxes, and submitted the bill to the Governor; and

**WHEREAS**, it remains unclear whether the *Tyler v. Hennepin County* decision, or the pending changes to state law will impact past auctions, including the auction held by Saratoga County in March 2023; and

**WHEREAS**, a budget amendment is necessary pending forthcoming interpretation or guidance issued by the state legislature, executive state agencies, or by any Court with competent jurisdiction; now, therefore, be it

**RESOLVED**, that this Board is authorized to amend the 2023 County Budget and account for a reduction in revenue derived from the sale of tax delinquent real property from \$750,000 to \$0, and further reducing the fund balance by \$750,000.00; and it is further

**RESOLVED**, that the 2023 Saratoga County Budget is amended as follows:

## RESOLUTION 178- 2023

**Introduced by Real Property Tax: Supervisors Ostrander, Barrett, Edwards, Lawler and Wright**

### **AUTHORIZING A BUDGET TRANSFER TO FUND THE INVESTIGATION OF TWO TAX DELINQUENT PARCELS FOR ENVIRONMENTAL CONTAMINATION AND AMENDING THE 2023 BUDGET IN RELATION THERETO**

**WHEREAS**, pursuant to Resolution 24-2023, a Capital Reserve Fund known as the “Contaminated Real Property Investigation Reserve Fund” (“Reserve Fund”) was established to finance the cost of the environmental restoration investigation of tax delinquent properties; and

**WHEREAS**, Resolution 24-2023 authorized funding the Reserve Fund by an amount not to exceed one hundred thousand (\$100,000) dollars from surplus revenues from the County’s 2023 tax foreclosure auction and ten percent (10%) from each subsequent auction; and

**WHEREAS**, on May 25, 2023, the United States Supreme Court issued its decision in *Tyler v. Hennepin County* and held that a taxing jurisdiction’s retention of surplus funds from a tax foreclosure proceeding is unconstitutional in violation of the Takings Clause; and

**WHEREAS**, the *Tyler v. Hennepin County* decision has temporarily caused Saratoga County’s Tax Enforcing Officer to question whether the County can use surplus revenue from the County’s March 2023 in rem tax foreclosure auction to fund the Reserve Fund; and

**WHEREAS**, the Tax Enforcing Officer has identified two properties that require a site investigation to ascertain the extent of any environmental contamination: Tax Parcel #104.-1-37.21 located on Route 32N in the Town of Northumberland (“Perry’s Automotive Center”), and Tax Parcel 243.84-2-6 located on Hudson Avenue in the Town of Stillwater (“Milt’s Body Shop & Auto Exchange”); and

**WHEREAS**, the Tax Enforcing Officer estimates that twenty-five thousand (\$25,000) dollars will cover the expense of conducting a site investigation on each Tax Parcel; and

**WHEREAS**, the Tax Enforcing Officer, in his role as the Saratoga County Treasurer, maintains a Professional Services line account that can be drawn upon to fund the engagement of an environmental testing firm to conduct site investigations; and

**WHEREAS**, this Board’s Real Property Tax Committee and Saratoga County’s Tax Enforcing Officer, recommend a transfer of fifty thousand (\$50,000) dollars from the County’s

Fund Balance to the County Treasurer's Professional Services line account to conduct site investigations at Tax Parcel #104.-1-37.21 located on Route 32N in the Town of Northumberland and Tax Parcel 243.84-2-6 located on Hudson Avenue in the Town of Stillwater; now, therefore, be it

**RESOLVED**, that the Tax Enforcing Officer is authorized to transfer fifty thousand (\$50,000) dollars from the County's Fund Balance to the County Treasurer's Professional Services line account to conduct site investigations at Tax Parcel #104.-1-37.21 located on Route 32N in the Town of Northumberland and Tax Parcel 243.84-2-6 located on Hudson Avenue in the Town of Stillwater; and it is further

**WHEREAS**, the Centers for Disease Control and Prevention via the New York State Department of Health/Health Research Incorporated (NYS DOH/HRI), is providing funding as part of the U.S. Strengthening Public Health Infrastructure, Workforce and Data Systems Award, and has notified the Saratoga County Department of Health (SCDOH) it is eligible to receive a five (5) year grant in the amount of \$136,944 per year, effective December 1, 2022, through November 30, 2027, totaling \$684,720, to create a stronger, more resilient public health care system that is prepared to respond to future health care crises; and

**WHEREAS**, our Health and Human Services Committee and the Commissioner of the Department of Health have recommended the acceptance of the NYS DOH/HRI five (5) year grant in the amount of \$136,944 per year, effective December 1, 2022, through November 30, 2027, totaling \$684,720; and

**WHEREAS**, the acceptance of these funds requires this Board's approval and amendments to the 2023-2027 County Budgets; now, therefore, be it

**AUTHORIZING AN AMENDED TOWER LICENSE  
AGREEMENT WITH CELLCO PARTNERSHIP, D/B/A VERIZON  
WIRELESS, FOR THE PLACEMENT OF COMMUNICATIONS  
EQUIPMENT ON THE COUNTY'S RADIO COMMUNICATIONS TOWER IN THE  
TOWN OF EDINBURG**

**WHEREAS**, as part of the County's Emergency Radio System, the County constructed a radio communications tower on lands located at 393 Military Road, in the Town of Edinburg, which lands are identified on the Saratoga County Tax Maps as Tax Parcel #54.-1-4; and

**WHEREAS**, the County does not own the parcel upon which the radio communications tower was constructed in the Town of Edinburg, but instead was granted an easement by the landowner, Roger Scott, to construct, operate and maintain the radio communications tower on said site; and

**WHEREAS**, Cellco Partnership, d/b/a Verizon Wireless, ("Verizon Wireless") is interested in licensing space on the County's Communications Tower in the Town of Edinburg for the placement, operation, and maintenance of communications equipment in support of the operation of Verizon Wireless's communications network; and

**WHEREAS**, the County's easement agreement with Roger Scott, dated August 6, 2008, provides that if the County co-locates antennas or other communications equipment on the tower for non-governmental or commercial purposes, the County shall pay to Roger Scott fifty per cent (50%) of any rental or license fee received from the owners of such antennas or other communications equipment; and

**WHEREAS**, our Public Safety Committee and the Director of Emergency Management have recommended that the County enter into an amended Tower License Agreement with Cellco Partnership, d/b/a Verizon Wireless for the placement of its communications equipment on the County's Communications Tower in the Town of Edinburg for an initial term of two (2) years commencing on August 1, 2023, and will automatically renew for nine (9) additional terms of two (2) years each, at an initial rental cost to Verizon Wireless of \$30,000 per year during the initial two (2) year term, subject to a two percent (2%) yearly increase for each renewal term of two (2) years over the preceding two (2) year term; now, therefore, be it

**RESOLVED**, that the Chair of the Board is hereby authorized to execute an amended Tower License Agreement with Cellco Partnership, d/b/a Verizon Wireless, of Bedminster, New

Jersey, granting a license to Cellco Partnership, d/b/a Verizon Wireless, authorizing the placement, operation and maintenance of communications equipment on the County's Communications Tower in the Town of Edinburg, for an initial term of two (2) years commencing on August 1, 2023, and will automatically renew for nine (9) additional terms of two (2) years each, at an initial rental cost to Verizon Wireless of \$30,000 per year during the initial two (2) year term, subject to a two percent (2%) yearly increase for each renewal term of two (2) years over the preceding two (2) year term; and, be it further

RESOLVED, that pursuant to its Agreement with Roger Scott dated August 6, 2008, the County shall pay fifty percent (50%) of the rent received from Cellco Partnership, d/b/a Verizon Wireless, its successors or assigns, to Roger Scott; and, be it further

RESOLVED, that the form and content of such Tower License Agreement shall be subject to the approval of the County Attorney.

**AUTHORIZING AN AMENDED TOWER LICENSE  
AGREEMENT WITH CELLCO PARTNERSHIP, D/B/A VERIZON  
WIRELESS, FOR THE PLACEMENT OF COMMUNICATIONS  
EQUIPMENT ON THE COUNTY'S RADIO COMMUNICATIONS TOWER IN THE  
TOWN OF LAKE LUZERNE**

**WHEREAS**, as part of the County's Emergency Radio System, the County constructed a radio communications tower on lands located at 466 Lake Avenue, in the Town of Lake Luzerne, County of Warren, owned by the Town of Lake Luzerne through its Luzerne Water District; and

**WHEREAS**, said radio communications tower is commonly known as the Lake Luzerne Tower; and

**WHEREAS**, the County does not own the parcel upon which the radio communications tower was constructed in the Town of Lake Luzerne, but instead was granted an easement by the Town of Lake Luzerne, acting on behalf of the Luzerne Water District, to construct, operate and maintain the radio communications tower on said site; and

**WHEREAS**, Cellco Partnership, d/b/a Verizon Wireless, ("Verizon Wireless") is interested in licensing space on the County's Communications Tower in the Town of Lake Luzerne for the placement, operation and maintenance of communications equipment in support of the operation of Verizon Wireless's communications network; and

**WHEREAS**, the County's easement agreement with the Town of Lake Luzerne dated April 26, 2010, provides that if the County co-locates antennas or other communications equipment on the tower for non-governmental or commercial purposes, the County shall pay to the Town of Lake Luzerne fifty per cent (50%) of any rental or license fee received from the owners of such antennas or other communications equipment; and
