AUTHORIZING THE ACCEPTANCE OF THE ADOLESCENT TOBACCO USE PREVENTION ACT GRANT FROM THE NEW YORK STATE DEPARTMENT HEALTH AND AMENDING THE COUNTY 2023 BUDGET IN RELATION THERETO

WHEREAS, the Adolescent Tobacco Use Prevention Act (ATUPA) regulates the sale of tobacco and vaping products to restrict their access by youth and young adults, including banning the sale of flavored vapor products, ending price discounts on tobacco and vapor products, banning exterior display of tobacco and vapor product ads near schools, stopping shipment and delivery of cigarettes and vapor products to private residents, increasing retailer penalties for tobacco sales violations, and raising the minimum legal sale age to purchase tobacco and vapor products; and

WHEREAS, the New York State Department of Health (NYSDOH) provides funding to support Local Health Department investigations of retailers to ensure compliance with ATUPA; and

WHEREAS, our Health and Human Services Committee and the Commissioner of the Department of Health have recommended the acceptance of the NYSDOH grant in the amount of \$67,437, for the term April 1, 2023 through March 31, 2024; and

WHEREAS, the acceptance of these funds requires this Board's approval and amendments to the 2023 County Budget; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby authorizes the acceptance of the NYS DOH grant in the amount of \$67,437, for the term April 1, 2023 through March 31, 2024 and amending the 2023 budget; and it is further

AUTHORIZING THE ACCEPTANCE OF AN IMMUNIZATION ACTION PLAN GRANT FROM THE NEW YORK STATE DEPARTMENT OF HEALTH

WHEREAS, the New York State Department of Health (NYSDOH) has notified the Saratoga County Department of Health (SCDOH) that it is eligible to receive a five (5) year IAP grant in the amount of \$118,680 per year, effective April 1, 2023, through March 31, 2028, totaling \$593,400; and

WHEREAS, our Health and Human Services Committee and the Commissioner of the Department of Health have recommended the acceptance of the NYSDOH five (5) year IAP grant in the amount of \$118,680 per year, effective April 1, 2023, through March 31, 2028, totaling \$593,400; and

AUTHORIZING A RENEWAL AGREEMENT WITH BERKSHIRE FARM CENTER AND SERVICES FOR YOUTH, INC. FOR THE OPERATION OF THE ENHANCED STEPPING STONES PROGRAM

WHEREAS, as a result of the Raise the Age legislation enacted in 2017, the age of criminal responsibility for youth who commit crimes was raised to 18 years of age effective October 1, 2018; and

WHEREAS, under the provisions of the Raise the Age (“RTA”) law, counties are to be reimbursed for all incremental costs associated with the implementation and ongoing services associated with raising the age of criminal responsibility, including local costs incurred in such areas as law enforcement, local detention, court services, Sheriff’s transportation, probation, youth services, and capital expenditures; and

WHEREAS, in order to qualify for reimbursement of RTA related expenditures, counties are required to adhere to the New York State imposed property tax cap and submit to the State for approval a comprehensive plan of work for raising the age locally which identifies eligible incremental costs for which reimbursement will be required; and

WHEREAS, pursuant to Resolutions 114-2020, 197-2021, and 237-2022, the County entered into agreements with Berkshire Farm Center and Services for Youth, Inc. (“Berkshire Farm Center”) for the provision of intensive family-based in-home case management services to at-risk youth for terms of approximately one (1) year each; and

WHEREAS, pursuant to Resolution 280-2022, the County entered into an agreement with Berkshire Farm Center for the provision of intensive family-based in-home case management services to at-risk youth for a term from October 1, 2022 through September 30, 2023; and

WHEREAS, our Health and Human Services Committee and the Commissioner of Social Services have recommended that the County enter into a renewal agreement with Berkshire Farm Center for the provision of intensive family-based in-home case management services to at-risk youth for a term commencing on October 1, 2023 through September 30, 2024, at an annual cost of \$110,880; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute a renewal agreement with Berkshire Farm Center and Services for Youth, Inc., of Canaan, New York, for the provision of its Enhanced Stepping Stones Program which provides for the provision of intensive family-based in-home case management services to at-risk youth for a term commencing on October 1, 2023 through September 30, 2024, at an annual cost of \$110,880; and it is further

AUTHORIZING THE TRANSFER OF FUNDS TO THE DEPARTMENT OF JUSTICE EQUITABLE SHARING ACCOUNT

WHEREAS, the U. S. Department of Justice and the U. S. Department of Treasury Asset Forfeiture Programs, are first and foremost, law enforcement programs, which deprive criminal organizations and other wrongdoers of the proceeds of their crimes; and

WHEREAS, the benefits of asset forfeiture is victim compensation, and the potential to share federal forfeiture proceeds with cooperating state and local law enforcement agencies through the “Equitable Sharing Program” (Program), which Program enhances cooperation amongst federal, state, local, and tribal law enforcement by providing valuable additional resources to state and local enforcement agencies; and

WHEREAS, the Saratoga County Sheriff’s Office has been the recipient of funds from the Program, and Program participants must comply with the policies and procedures outlined in the “Guide to Equitable Sharing for State, Local, and Tribal Law Enforcement Agencies” (July 2018), the “Guide”; and

WHEREAS, the Sheriff’s Office expended funds for a permissible project pursuant to the Guide, however prior authorization from the Money Laundering and Asset Recovery Section (MLARS) was required and not obtained, in the amount of \$27,686, and also directed funds to a nonqualifying subrecipient in the amount of \$1,950 for a total amount of \$29,636, which total amount must now be re-deposited, at the request of the Equitable Share Program Coordinator of the U.S. Department of Justice, into the Department of Justice Equitable Sharing Account by September 25, 2023; and

WHEREAS, pursuant to Saratoga County’s Regulations for Contracts and Spending, Chapter 2, section H, subsection IV(C)(6): Expenditures not requiring a contract or purchase order, include expenditures mandated by federal or state law or regulation, or directed by an Order of a Court; and

WHEREAS, our Law and Finance Committee and the Sheriff have recommended, pursuant to Saratoga County’s Regulations for Contracts and Spending, Chapter 2, section H, subsection IV(C)(6), and as requested by the Equitable Share Program Coordinator of the U.S.

Department of Justice, that funds in the amount of \$29,636 be re-deposited into the Department of Justice Equitable Sharing Account by September 25, 2023; now, therefore, be it

RESOLVED, that the Saratoga County Treasurer and Budget Officer, pursuant to Saratoga County's Regulations for Contracts and Spending, Chapter 2, section H, subsection IV(C)(6), and as requested by the Equitable Share Program Coordinator of the U.S. Department of Justice, are authorized to take any steps necessary to effectuate the re-deposit of funds in the amount of \$29,636 into the Department of Justice equitable Sharing Account by September 25, 2023; and it is further

RESOLVED, that the form and content of such agreements shall be subject to the approval of the County Attorney; and it is further
