This is skilled work requiring responsibility for applying welding techniques to the dismantling of work machinery and equipment and the installation of new machinery and equipment. Duties are performed under the direct supervision of a higher-level maintenance employee. Supervision is not a function of this position. Related duties will be performed as required.

Typical work activities for this opportunity are... (*Illustrative only)

- Operates welding machines in the cutting and repairing of road maintenance machines such as mowers, tractors, snowplows, graders, and salt and sand trucks;
- Cuts, welds, brazes and solders metal parts in repair and replacement of parts and replacement of parts and equipment used in the construction and maintenance of the highway systems;
- Fabricates, rebuilds, or remanufacture pieces of equipment that are worn or broken where welding or associated metal work is the major skill required;
- Fashions, repairs, or replaces tools and equipment such as rakes, plow and plow parts, push frames for trucks, truck bodies, fenders, etc.;
- Assists in dismantling of work machinery and equipment and assists in the installation of new machinery and equipment;
- Repairs old equipment and keeps it in good condition;
- Uses portable welding equipment at the job site.
