### Flexible billing options to fit your needs

- Monthly This requires an electronic funds transfer (EFT) setup that automatically deducts the payments from your checking or savings account each month.
- **Quarterly** This is the default payment option if you don't complete an EFT form. Your first quarterly bill will be mailed to you after you enroll.
- Annually To select this option, mail in the payment for the entire year with your first quarterly bill.

#### Three easy ways to enroll:

Mail	Complete the enrollment form and mail it in the postage-paid envelope. Remember to include the EFT authorization form if you would like to select the monthly billing option.
Online	Visit metlife.com/mybenefits. Online enrollment includes only the quarterly and annual billing options. First time users of MyBenefits will need to complete a simple online registration prior to enrolling.
Phone	Call 1-800-GET-MET8 (1-800-438-6388) to speak with a Customer Service Representative. For prompt service, just follow these instructions:

   Say "Dental" when asked to state the product you are calling about.
- Enter your Social Security Number when asked/your ID number located above the rate chart.

- If you prefer the monthly payment option, you can set up your EFT when enrolling by phone.
