• Authorizing an agreement with NTS Data Services, LLC for the maintenance and support of the board of election voter data base software.

<u>BUDGET IMPACT</u>: No Budget Impact. Funds are included in the Department Budget. This agreement will be for a three-year term with the first-year cost totaling \$70,364.

• Authorizing the County Auditor to approve tax refunds, corrections, and credits in amounts not to exceed \$2,500.

BUDGET IMPACT: No Budget Impact.

This is an annual housekeeping item and a joint recommendation made by the Director of Real Property and the County Treasurer. The Auditor will report all refunds, corrections, or credits to the Real Property Committee.

- Amending the 2024 Compensation schedule under the Sheriff's Office.
 <u>BUDGET IMPACT</u>: No Budget Impact. Funds are included in the Department Budget.
 This amendment will retitle one Fiscal Manager position to one Accounting Supervisor within the Sheriff's Office.
 - Adopting a local law identified as introductory No. 2, print No. 1 of 2023, relative to amending the 2024 Saratoga County Compensation Schedule to provide salary and cost-of-living increase for certain County officials.

BUDGET IMPACT: No Budget Impact.

This Local Law adopts the salary and cost-of-living increase for certain elected or appointed County officials previously approved by the Board of Supervisors. A public hearing on this item will be held January 10, 2024 at 4:30pm.
