### AMENDING RESOLUTION 305 – 2024

**A LOCAL LAW AMENDING THE 2025 COUNTY COMPENSATION SCHEDULE TO PROVIDE A SALARY AND COST-OF-LIVING INCREASE FOR CERTAIN COUNTY OFFICIALS**
